Welcome to the Vice-Chancellor

The Vice-Chancellor welcomed the members of the August House.

Shri Ashok Goyal stated that after knowing that Professor Arun Kumar Grover had been appointed as the Vice-Chancellor of the University, it was going through his mind whether Professor Grover is an outsider or insider. After thinking over for some time, he came to the conclusion that Professor Grover could not be considered as an outsider as he was a proud student of Panjab University and teacher as well, who had taken over as Vice-Chancellor and he as a member of the Syndicate would have relished had he been invited by the University at the time of taking over the charge as Vice-Chancellor and he would have taken pride in welcoming him on the very first day. Anyhow, it could not happen. It is never too late and he welcomed the Vice-Chancellor on his own behalf and on behalf of his colleagues and wished him all the best. He was sure that the Vice-Chancellor would be able to carry forward the University to greater heights in future.

Shri Gopal Krishan Chatrath stated that he being the seniormost person in age and member of the Syndicate and Senate welcomes the Vice-Chancellor, the illustrious son of this land, who had taken over the charge and authority as the Vice-Chancellor of this prestigious University. It is said, "Some people get status because of the post they held, whereas some give status to the post they hold. He wished and prayed that by taking over as the Vice-Chancellor, his association would give status to the University as it deserved. It was a

fact that when Professor Grover took over as Vice-Chancellor, he took off from the High Court and enquired the Registrar as to what is the programme and the Registrar informed him that Professor Grover would take over at 9.00 a.m. Herein before, the members of the Syndicate and Senate, Deans and others always get an opportunity to welcome the new Vice-Chancellor. Anyhow, he felt happy even from far. He knew that this University would certainly rise. Under the guidance of the Vice-Chancellor, the University would be known at the global level. He was hopeful that each Department/segment of the University, maybe Law, Sciences, Medical Sciences, Social Sciences, Languages, would get equal benevolence from the Vice-Chancellor so that they could bask in glory. Last year, when they were welcoming the students on the first day of admission, he prayed that their wishes be fulfilled and before he died, the Department of Laws is ranked at number 1 in the country. He had treated this University as his mother. Whatever he had learnt, it is from the Department of Laws and whatever he is today, was because of this University. So far as his colleagues are concerned, he hoped they would also express the same very feelings. The members of the Syndicate comprised of President of Punjab and Chandigarh College Teachers Union, President of Principals Association, Lecturers Association and three women, i.e. Professor Pam Rajput, Principal Tejinder Kaur, Principal Junesh Kumari Kackria. Professor Pam Rajput would not be able to attend the meeting as she was out of station. They get advice from everybody and try to help the University in its smooth functioning. He ensured that the members would extend every kind of support which the Vice-Chancellor expected from them. With these words, he once again congratulated the Vice-Chancellor and conveyed his thanks to the Chancellor, who did not take a minute to appoint Professor Arun Kumar Grover as Vice-Chancellor of Panjab University after submission of report by the Search Committee headed by Justice (Retd.) Leila Seth. They must also be grateful and express their thanks to the worthy Chancellor whose wise eyes had chosen a gem for their University.

Shri Jarnail Singh stated that he would also take an opportunity to congratulate the Vice-Chancellor who is an old student and teacher of the University. He wished that the University might achieve new heights under his guidance and would work in more fair and transparent manner.

Principal Junesh Kumari Kackria congratulated the Vice-Chancellor on her own and on behalf of President and General Secretary of DAV Managing Committee. She said that they all are here to work as a team for the academic excellence and serve the society.

Principal Tejinder Kaur stated that an able and an honest person has been chosen by the Chancellor as Vice-Chancellor of this University, who would serve in a challenging time. She appreciated the appointment of the Vice-Chancellor. She hoped that the affiliated Colleges, including the Institutions run under the aegis of SGPC would flourish under the leadership of the Vice-Chancellor, especially in view of the unique status of the Panjab University which once received grant from the Governments in the ratio of 60:40 (60% from the Central Government and 40% from the Punjab Government). She congratulated the Vice-Chancellor on her own behalf and on behalf of the SGPC Institutions and their managements. Professor Naval Kishore stated that he acknowledged the orders of the Vice-President of India and the Chancellor of the University with respect to the appointment of Professor Grover as Vice-Chancellor of this University. As stated by some of the members, including Shri Goyal, Professor Grover is an alumnus and teacher of the Panjab University. He (Professor Naval) assured that they would extend him unstinted support so that the University could achieve new heights under his stewardship.

Principal K.N. Kaul stated that he acknowledged the appointment of Professor Grover as Vice-Chancellor of this University with great happiness and hope, as the Vice-Chancellor of this University is an alumnus of D.A.V. College, Jalandhar, as he was also. He on his own behalf and on behalf of the D.A.V. Managing Committee and on behalf of his colleagues extended heartiest congratulations to him. They would always remain fruitful and truthful to the University and their association would definitely enhance the image of the University.

Principal R.S. Jhanji congratulated the Vice-Chancellor and hoped that the University would achieve new heights under his stewardship.

Professor M. Shakeel Khan said that he congratulated the Vice-Chancellor from the core of his heart. He hoped that since Professor Grover is associated with the University since long, he would be able to carry the University much further.

Dr. P.S. Gill stated that he on his own behalf and on behalf of the Punjab & Chandigarh College Teachers' Union welcomed the Vice-Chancellor to this august House. The Syndicate is the regulatory body which also approves the appointments of teachers in affiliated Colleges and their code of conduct. He was sure that with the co-operation and guidance of the members of the Syndicate, the Vice-Chancellor would be able to solve the problems of the affiliated Colleges and also protect the rights of the teachers.

Dr. Dinesh Talwar stated that he was a student of Chemistry and associated with the University for the last about 12 years. He also congratulated Professor Grover on becoming Vice-Chancellor of this He endorsed the viewpoints expressed by Principal University. Tejinder Kaur and said that it was necessary to maintain balance between the University Teaching Departments and the affiliated Colleges. In terms of number of affiliated Colleges, perhaps, Panjab University was the largest University in the region with whom about 190 Colleges are affiliated. Being a student of Chemistry and now a member of this Governing body of this University, he knew that the affiliated Colleges were always at the receiving end. He, however, hoped that it would not continue any more. Whatever had been achieved by this University, including status of five star from the NAAC, had been with the full co-operation from the affiliated Colleges. On the other hand, the affiliated Colleges are not growing well as they should have been. He requested the Vice-Chancellor to devote as much time as possible for the University as well as for its affiliated Colleges so that both grow together and take this University to even more heights.

Principal Gurdip Sharma congratulated the Vice-Chancellor on his own behalf and on behalf of Federation of Principals of Punjab and Chandigarh and extended hearty welcome to him. He stated that there were several issues some of which had been highlighted by Principal Tejinder Kaur and Dr. Dinesh Talwar. He hoped that the Vice-Chancellor would understand all these issues and solve them.

Dr. Mukesh Arora congratulated the Vice-Chancellor and said that he would definitely succeed as he had the habit of listening to the problem and remaining cool all the time. He requested the Vice-Chancellor to give special attention to the problems of the affiliated Colleges and the teachers.

Principal Janmit Singh welcomed the Vice-Chancellor on his own behalf and on behalf of his Principal colleagues. Though, there were problems, the Vice-Chancellor would definitely succeed in solving them if they remain together and listen to one another carefully.

The Vice-Chancellor thanked the members for their kind sentiments.

1(i). The Vice-Chancellor said, –

"(1) I am grateful to His Excellency, Mohd. Hamid Ansari, Vice-President of India, and the Chancellor of Panjab University, for appointing me as the 12th Vice-Chancellor of this pioneer University. It is a tremendous responsibility and I am very much aware of it. I will try to do my very best to come up to the expectations of the society in general and the University community in particular.

This is my first meeting of the present Syndicate and I take this opportunity to welcome all of you, the distinguished members. I expect from all of you a lot of guidance, full support and co-operation in discharging my responsibilities as the Vice-Chancellor, in complete conformity with the statutes, regulations and rules, for the overall growth of this prestigious University. I would like to assure this August House that it would be my utmost endeavour to take this University to newer and greater heights with the co-operation of all of you.

I place on record the Syndicate's appreciation of the services rendered by Professor R.C. Sobti as the Vice-Chancellor of the University from July 22, 2006 to July 22, 2012. Professor Sobti has set up several new landmarks during his six years tenure. An appreciation letter from the Syndicate may please be allowed to be issued to him.

(2) As per the decision on the agenda Item 1(2) of the meeting of the Syndicate held on 23.02.2007, it is proposed that in recognition of his services rendered to the University as 'teacher' Vice-Chancellor, Professor R.C. Sobti may please be considered for conferment of the title of Professor Emeritus, under Regulation 3 at page 114 of P.U. Calendar, Volume I, 2007.

Vice-Chancellor's Statement

- (3) Professor R.K. Kohli has been selected for the award of J.C. Bose Fellowship by the Ministry of Science & Technology, Department of Science & Technology, New Delhi. This Fellowship carries a total budget of Rs.68,00,000/- for a duration of 5 years [which includes Fellowship of Rs.15,00,000/- (Rs.25,000/p.m.) and a Research Grant and Overhead Charges of Rs.53,00,000/-]. A letter of felicitations for this prestigious award of Fellowship to Professor R.K. Kohli may please be allowed to be sent on behalf of the Syndicate. A very few Professors of Universities of this country have been able to get his award.
- (4) I propose that the Dean of University Instruction, being the Academic Head of all the Teaching Departments on the Campus, be invited to be present in the Syndicate meeting. A given Syndicate may take a call on this during its first meeting.
- (5) The American Association of Pharmaceutical Scientists has recently selected Mr. Rishi Kapil as the recipient of the 2012 AAPS Graduate Student Award in Quality by Design and Product Performance for the work carried out at University Institute of Pharmaceutical Sciences, Panjab University, under the guidance of eminent Professor Bhupinder Singh Bhoop. This award represents the Quality by Design (QbD) Focus Group belief in the synergy of an integrated and multidisciplinary approach for advancing product quality for patient benefit. The Award will be bestowed along with a commemorative plaque and a monetary student award of US \$500.
- I am happy to share that the University Grants (6) Commission has selected the University Institute of Pharmaceutical Sciences, Panjab University, Chandigarh for the Special Assistance Programme (SAP) for upgradation/continuation from Career Advancement Scheme Phase-I to Career Advancement Scheme Phase-II for a period of 5 years (1.4.2012 to 31.3.2017) in the thrust areas of Drug Discovery, Development and Delivery System - Anti Cancer, Metabolic Disorders, Leucorrhoea and related women diseases and Alzheimer's Disease. The Review Committee of UGC has recommended the name of Professor Bhupinder Singh Bhoop as the Co-ordinator for the CAS-II Programme under SAP. The financial assistance approved for implementing the present phase is Rs.87.50 lac (non-recurring Rs.48.00 lac + recurring Rs.39.50 lac) for 5 years."

The Syndicate thanked the Hon'ble Chancellor for appointing Professor Arun Kumar Grover, a distinguished scientist, as Vice-Chancellor of the Panjab University.

The Syndicate placed on record its appreciation for the services rendered by Professor R.C. Sobti as Vice-Chancellor of Panjab University.

Referring to proposal at Sr. No. 2, Shri Ashok Goyal pointed out that as per the decision of the Syndicate dated 23.2.2007(Para 1(2)), the title of 'Professor Emeritus' was conferred on the former Vice-Chancellors and Deans of University Instruction in recognition of their scholarship and conspicuous service to the University on the celebration of Diamond Jubilee Year of the Panjab University, under Regulation 3 at page 114 of P.U. Calendar, Volume I, 2007. As such, the decision is not general in nature and the title of 'Professor Emeritus' could not be conferred upon a person because of holding the position of Vice-Chancellor/Dean of University Instruction. Therefore, the title of 'Professor Emeritus' should be conferred upon Professor R.C. Sobti keeping in view the provision of Regulation 3 at page 114 of P.U. Calendar, Volume I, 2007.

Principal Tejinder Kaur observed that conferring of the title of 'Professor Emeritus' was not a ritual ceremony rather it is conferred upon the basis of one's scholarship and conspicuous service rendered to the University.

Shri Ashok Goyal clarified that it was never decided by the Syndicate and Senate to confer the title of 'Professor Emeritus' on all the former Vice-Chancellors and Deans of University Instruction.

The point made by Shri Ashok Goyal was noted.

As far as the proposal of the Vice-Chancellor at Sr.No. (4) was concerned, some members observed that it should not be made a practice to invite the Dean of University Instruction to be present in the Syndicate meetings, he being the academic head of the teaching departments on the Campus. In case his presence was required on any item in the meeting of the Syndicate, he might be invited. A few members welcomed this suggestion, whereas a few others said that the proposal could be brought at a subsequent meeting of the Syndicate.

RESOLVED: That -

- (1) it be recommended to the Senate that, in recognition of his scholarship and conspicuous service to the University, Professor R.C. Sobti, who has been the teacher and Vice-Chancellor at the Panjab University, be conferred the title of Professor Emeritus', under Regulation 3 at page 114, P.U. Calendar, Volume I, 2007.
- (2) felicitations of the Syndicate be conveyed to -
 - Professor R.K. Kohli on his having been selected for the award of J.C. Bose Fellowship by the Ministry of Science & Technology, Department of Science & Technology, New Delhi. This Fellowship carries a total budget of Rs.68,00,000/- for a duration of 5 years;

AAPS Graduate Student Award in Quality by Design and Product Performance for the work carried out at University Institute of Sciences. Pharmaceutical Paniab University, under the guidance of eminent Professor Bhupinder Singh Bhoop:

- (3) The information contained in the Vice-Chancellor's statement at Sr. No. (6), be noted.
- Date for the next 1(ii) The Vice-Chancellor had proposed holding of the next meeting Syndicate meeting of the Syndicate in the last week of August, however, conforming the views of majority of Syndicate members, the next meeting of the Syndicate was fixed on Saturday, 8th September, 2012.

After the decisions on the Vice-Chancellor's statement were taken, the members started general discussions.

Shri Jarnail Singh stated, earlier, sometimes they had observed that the proceedings of the Syndicate and Senate meetings are not recorded correctly. He, therefore, pleaded that along with the hard copy of the tentative minutes of the meetings of the Syndicate and Senate, the copies of the DVDs should also be supplied to the members, which would prevent distortion of minutes in any manner.

Principal Janmit Singh said that the information in the DVDs is confidential and could be misused. He, therefore, suggested that they should trust the Vice-Chancellor.

Principal Tejinder Kaur said that she was not in agreement with the view expressed by Principal Janmit Singh as sometimes, they found altogether different decisions recorded in the minutes.

The Vice-Chancellor said that any member could ask for the copies of the DVDs.

Shri Gopal Krishan Chatrath stated that the decision recorded in the minutes should be compared from the DVDs by the Registrar and wherever he felt that it is not correctly recorded, he could correct the same.

Dr. P.S. Gill stated that in the minutes of the meeting of the Senate dated 20.12.2011 one of the decisions was quoted incorrectly and the correct decision was that all those teachers/Principals who have been duly granted approval by the University according to the Syndicate decision/the then existing UGC guidelines, be considered to have been duly approved for the purpose of selection and appointment while shifting from one institution to another either in the same/or promotional capacity.

The Vice-Chancellor stated that it was impossible to record the proceedings verbatim et literatim as it would make the proceedings unnecessary lengthy.

Continuing, the Vice-Chancellor stated that, in future, the tentative minutes would be circulated to the members. If they find anything in wrong in the recording of the minutes, they should point out discrepancy/ discrepancies, within a stipulated period. The discrepancies so pointed out would be verified by the Registrar after going through the DVDs records. Thereafter, corrections, if any, would be incorporated in the final minutes.

Shri Ashok Goyal stated that whatever suggestion had been given by the Vice-Chancellor, in fact, it was already in vogue. As far as confidentiality was concerned, no confidentiality is involved in it as the DVDs are to be supplied to the general public under RTI Act.

Professor Naval Kishore suggested that the solution to this problem was that the resolve part of each and every item should be dictated so that there was no confusion about the decision finally arrived at.

Principal R.S. Jhanji was in full agreement with the suggestion made by Professor Naval Kishore.

Protection of pay of Dr. Gulshan Kumar, Assistant Professor, UILS **<u>4.</u>** Considered minutes dated 13.6.2012 (**Appendix-II**) of the Committee constituted by the Vice-Chancellor to decide the representation of Dr. Kirandeep Singh, Associate Professor requesting to pre-pone the dates of her promotion as Lecturer (Senior Scale), Reader, Associate Professor.

RESOLVED: That the recommendation of the Committee dated 13.06.2012, as per **Appendix**, be approved.

RESOLVED: That the term of appointment of Shri Kanwal Preet Singh, Assistant Professor in Computer Science & Engineering and Shri Jodh Singh, Assistant Professor in Mechanical Engineering (purely on contract basis) at S.S.Giri P.U. Regional Centre, Hoshiarpur, be extended for the academic session 2012-13 or till the posts are filled in on regular basis, whichever is earlier, on the same terms and conditions according to which they have worked previously during the session 2011-12, w.e.f. the date they start work in the Centre, under Regulation 5 at page 111 of P.U. Cal. Vol. I, 2007.

<u>6.</u> Considered if the pay of Dr. Gulshan Kumar, Assistant Professor, University Institute of Legal Studies be protected at ₹33310/- in the pay scale of ₹15600-39100 (Revised) +AGP ₹7000/- w.e.f. 6.9.2011, i.e. the date of his joining in the Panjab University, with the next date of increment on 1.7.2012.

- NOTE: 1. RAO has opined that as per appointment letter issued by the Establishment Dr. Gulshan Kumar, Assistant Professor in Economics of University Institute of Legal Studies is to be paid the pay as per University Rules in the pay scale of ₹15600-39100+AGP Rs.6000/-. As per position of the rules quoted by the office, an official who joins the Panjab University from the private organization is not entitled for the protection of pay. Therefore the case of the official is not covered under the rules.
 - It is stated that in another similar case of Dr. Deepti Laroia, Assistant Professor, UILS, who also joined from the non government affiliated College (GGDSD, College, Sector 32, Chandigarh), her pay which includes AGP of ₹7000/- already stands protected by the Syndicate (Para 12) dated 29.2.2012. In the said Syndicate meeting it has also been decided to protect the pay of other similarly placed person including Dr. Gulshan Kumar, who are at par with Dr. Deepti Laroia be also protected.
 - 3. A detailed office note enclosed (Appendix-III).

Shri Gopal Krishan Chatrath suggested that each and every case for protection of pay/fixation of pay should not be placed before the Syndicate rather the pay should be protected/fixed as per policy of the U.G.C./University and the Vice-Chancellor should be authorized to approve such case on behalf of the Syndicate.

RESOLVED: That the pay of Dr. Gulshan Kumar, Assistant Professor, University Institute of Legal Studies be protected at ₹33340/- (including AGP Rs.8000/-) in the pay scale of ₹15600-39100 (Revised) w.e.f. 6.9.2011, i.e. the date of his joining in the Panjab University, with the next date of increment on 1.7.2012.

RESOLVED FURTHER: That the Vice-Chancellor be authorized to approve the cases of protection of pay/fixation of pay, in future, on behalf of the Syndicate.

Appointments on compassionate ground

 - (i) the minutes dated 9.5.2012 (Appendix-IV) of the Committee constituted by the Vice-Chancellor to examine the cases for appointment on compassionate grounds for the year 2012.
 - (ii) the case of appointment of Shri Ved Parkash S/o Late Shri Ram Roop, Mali, as Clerk on compassionate grounds at Sr. No. 2 in the minutes of the Committee be approved along with other cases mentioned in the minutes.

NOTE: An office note enclosed (**Appendix-IV**).

Shri Ashok Goyal stated that since the query regarding appointment of Shri Ved Parkash as Clerk was made by the Committee, the reply was required to be submitted to the Committee. In fact, the query of the Committee was whether Shri Ved Parkash, whose father was Mali, could be appointed as Clerk. As per rules of various organizations, whosoever is to be appointed on compassionate grounds, he/she could not be appointed in a cadre above the cadre to which the deceased employee belonged. It was a case where the deceased employee was a Mali and his son was seeking appointment as Clerk. That was why the Committee raised the query. He, therefore, suggested that the case of appointment of Shri Ved Parkash should be referred back to the Committee.

Shri Gopal Krishan Chatrath suggested that a small Committee should be appointed to examine the rules of Central Government and Punjab Government for making appointments on compassionate grounds and suggest amendments, if any.

RESOLVED: That -

- the recommendations of the Committee constituted by the Vice-Chancellor to examine the cases for appointment on compassionate grounds for the year 2012, as per **Appendix**, be approved.
- (2) the case of appointment of Shri Ved Parkash S/o Late Shri Ram Roop, Mali, as Clerk on

compassionate grounds (Sr. No. 2 in the minutes of the Committee), be referred back to the Committee to consider his case in the light of the observation made by Shri Ashok Goyal.

RESOLVED FURTHER: That a small Committee be constituted to examine rules of Central Government and Punjab Government for making appointments on compassionate grounds and suggest amendments, if any.

At this stage, Principal R.S. Jhanji stated that in the meeting of the Senate dated 31.03.2012 some of the members had raised various issues pertaining to ex-cadre posts and the Vice-Chancellor had assured that the matter would be looked into. He wanted to know as to what action had been taken by the authority.

The Vice-Chancellor said that the action on the issue would be reported to the Syndicate in the form of Action Taken Report.

Appointment of Dean of University Instruction

<u>8.</u> Considered the appointment of Dean of University Instruction, Panjab University, Chandigarh, for a period of one year w.e.f. 1.9.2012, under Regulation 1 at page 105 of P.U. Calendar, Volume I, 2007.

NOTE: 1. Regulation 1 *ibid* reads as under:

"The Senate, on the recommendation of the Syndicate, may, from time to time appoint one of the University Professors to hold the office of the Dean of University Instruction. The term of appointment shall be for one year which may be renewed for one year more. The amount and nature of the allowance to be granted to the Dean of University Instruction for performing the duties attached to this office shall be determined by the Syndicate at the time of appointment."

2. Professor B.S. Brar, Dean of University Instruction, is retiring as Professor on 31.8.2012 after completion of 60 years of age.

RESOLVED: That it be recommended to the Senate that Professor R.K. Kohli, Department of Botany, be appointed Dean of University Instruction, Panjab University, Chandigarh, for a period of one year w.e.f. 1.9.2012, under Regulation 1 at page 105 of P.U. Calendar, Volume I, 2007.

The Syndicate placed on record its appreciation for the services rendered by Professor B.S. Brar as Dean of University Instruction.

At this stage, Principal Janmit Singh stated that the University should adopt the designation of Senior Professor for promotion from Professor to Senior Professor. Shri Gopal Krishan Chatrath proposed that the system of Senior Professor should be adopted by the University.

Shri Ashok Gopal said that probably it would not be correct to say that the said system was not operational in this University as they had already adopted the notification of the U.G.C. in toto wherein the designation of Senior Professor was also there. Moreover, some of the teachers had already submitted their bio-data for consideration for promotion as Senior Professor.

The Vice-Chancellor stated that the system of Senior Professorship had not been operative in most of the Universities in the country. Some of the IITs had summarily rejected the adoption of this system. In the Indian Institute of Sciences (I.I.Sc.), Bangalore, a Professor with 9 years standing is considered for the Grade Pay of the Senior Professor. However, this enhancement in Grade Pay get reflected only in the pay slips, and this information is not put in the public domain in the I.I.Sc. Website. It is desired that Professors and Senior Professors are designated as Professors and their duties remain the same. However, it was being viewed that in case the designation of Senior Professor is adopted, the status of a Professor, which is considered to be highest in academic circles, should not be compromised. In any case, if the system of Senior Professorship is to be adopted, a procedure has to be evolved to make the people aware of it, so that they could apply.

Dr. Jarnail Singh said that there did not exist any rule under which the teachers have submitted applications for promotion as Senior Professor.

Professor M. Shakeel Khan did not agree with the contention made by Dr. Jarnail Singh as the rule was already there.

The Vice-Chancellor said that an Official Resolution along with all the guidelines on the issue would be placed before the Syndicate. If the Resolution approved, those who had already submitted their applications for promotion as Senior Professors, would be asked to update their bio-data.

Re-fixation of pay of Dr. Rupinder Bir Kaur, Assistant Professor, University Business School

9. Considered the pay of Dr. Rupinder Bir Kaur, Assistant Professor, University Business School, be re-fixed at ₹24926/- w.e.f. 21.7.2010 with next date of increment on 01.07.2011 in the pay-scale of ₹15600-39100 +AGP of ₹6000/- on account of the revised LPC after getting effected the increment due on 1.7.2010 at previous institution. Information contained in the office note and the revised LPC (**Appendix-V**) was also taken into consideration.

RESOLVED: That the pay of Dr. Rupinder Bir Kaur, Assistant Professor, University Business School, be re-fixed at ₹24926/- w.e.f. 21.7.2010 with next date of increment on 01.07.2011 in the pay-scale of ₹15600-39100 +AGP of ₹6000/- on account of the revised LPC after getting effected the increment due on 1.7.2010 at previous institution.

Request of Professor Dharmanand Sharma, Department of Philosophy, for premature retirement **10.** Considered if the request dated 2.7.2012 (**Appendix-VI**) of Professor Dharmanand Sharma, Department of Philosophy, for premature retirement be accepted.

NOTE: During Syndicate Meeting dated 17.5.2012 (Para 24) the members observed that Professor Dharmanand Sharma should be requested to withdraw his request for pre-mature retirement.

The Vice-Chancellor said that Professor Dharmanand Sharma was requested repeatedly personally by him not to seek pre-mature retirement, but to no avail. However, he would once again request him as desired by the members.

This was agreed to.

RESOLVED: That the request dated 2.7.2012 (**Appendix-VI**) of Professor Dharmanand Sharma, Department of Philosophy, for premature retirement be acceded to.

Item 11 on the agenda was read out, viz. –

II. Dean of International Students

- (i) The term of appointment of the present Dean of International Students, Professor Gurmail Singh, Department of Economics, is with effect from 1.8.2011 to 31.7.2012.
- (ii) Regulation 1 at page 108 of P.U. Calendar, Volume 1, 2007:

"The Senate on the recommendation of the Syndicate may from time to time, appoint one of the University Professors to hold the office of Dean of Foreign Students. The term of appointment shall be for one year, renewable from year to year, but the maximum period shall exceed not three years (consecutively). The amount and nature of the allowance to be granted to the Dean of Foreign Students for performing the duties attached to the Office shall be

determined by the Syndicate at the time of his appointment."

III. Dean of Alumni Relations

- (i) The term of appointment of the present Dean of Alumni Relations, Professor Neelam Grover, University School of Open Learning, is with effect from 23.11.2011 to 22.11.2012.
- (ii) Regulation 1 at page 109 of P.U. Calendar Volume I, 2007:

"The Senate on the recommendation of the Vice-Chancellor and the Syndicate may appoint a Dean of Alumni Relations. Such appointment may be renewed from year to year but the maximum period for which a person may hold this office shall not exceed five (consecutive) years."

IV. Dean Research

The term of appointment of the present Dean research, Professor R.K. Kohli, Department of Botany is with effect from **1.1.2012 till further orders**.

NOTE: The appointment of Professor R.K. Kohli, Department of Botany, Dean Research has been approved till further orders but if he is appointed as Dean University Instruction on superannuation of the present D.U.I. on 31.8.2012 then his appointment to this effect needs to be

replaced by appointing some one other faculty members.

RESOLVED: That the term of present Dean Student Welfare (Women), Dean International Students, Dean of Alumni Relations, be extended by one year, and the Vice-Chancellor be authorized to take decision about Dean Research, on behalf of the Syndicate.

At this stage, Shri Gopal Krishan Chatrath pointed out that the appointment of Dean Student Welfare should have been placed before the Syndicate.

The Vice-Chancellor stated that the term of Professor A.S. Ahluwalia as Dean Student Welfare had been extended for another year w.e.f. 1.8.2012 to 31.7.2013 in anticipation of the approval of the Syndicate and the file was sent to the Syndicate Section for placing it before the Syndicate.

Shri Ashok Goyal stated that the item regarding appointment of Dean of Student Welfare should have been placed before the Syndicate. Further, though he was not against the appointment of Professor A.S. Ahluwalia as Dean of Student Welfare, to meet any emergency, his term should have been extended till further orders instead of extending for one year without the approval of the Syndicate.

The Vice-Chancellor clarified that the term of Professor Ahluwalia as DSW was going to end on 31.7.2012 and the Syndicate meeting was to be held on 4.8.2012. As such, he had no option but to extend his term. However, he fully agreed that Professor Ahluwalia should have been given extension as DSW till further order.

After discussion, it was -

RESOLVED: That the action of the Vice-Chancellor in extending the term of Professor A.S. Ahluwalia for one year w.e.f. 1.8.2012 to 31.7.2013, in anticipation of the approval of the Syndicate, be ratified.

Fixation of pay of Dr. Veena Puri, Assistant Professor at Centre for System Biology & Bioinformatics

12. Shri Ashok Goyal stated that the information given in the office note is incorrect and misleading, e.g. somewhere the name of Dr. Tankeshwar Kumar had been mentioned as Dr. Tankeshwar Sharma, etc. He observed that the office note should contain factual position and not inaccurate information.

The Vice-Chancellor said that the office would be asked to correct the note and the same be incorporated in the permanent record.

RESOLVED: That the travel subsidy given to Dr. Tankeshwar Kumar, Director, Computer Centre, for attending the Conference out of UGC Un-assigned Grant within the sanctioned amount, be modified as under:

Request of Mr. Surinder Kumar Puri, Sr. Asstt., Department of Defence & National Security Studies, for voluntary retirement **<u>15.</u>** Considered if Mr. Surinder Kumar Puri, Senior Assistant, Department of Defence & National Security Studies, be granted voluntary retirement w.e.f. 31.08.2012 (A.N.) as requested by him, under Regulations 17.5, 17.8 and 17.9 at page 133 of P.U. Calendar, Volume I, 2007 and he be sanctioned retrial benefits, Gratuity as admissible under Regulation 15.1 at page 131 of P.U. Calendar Volume I, 2007 and Leave encashment etc.

NOTE: 1. Regulations 17.5, 17.7, 17.8 and 17.9 *ibid* read as under:

"17.5. A University employee who has put in not less than 20 years' qualifying service may, by giving notice of three months' in writing to the appropriate authority, retires from the service voluntarily. A notice of less than three months may be accepted by the appropriate authority in deserving cases.

17.7 A notice of Voluntary retirement, given after completion of 20 years qualifying service will require acceptance by the appropriate authority if the date of retirement, on the expiry of notice would be earlier than the date on which the employee concerned could have retired voluntarily under the existing regulations. provisions of Such acceptance may generally be given in all cases except those (a) in which disciplinary proceeding are pending or contemplated against the employee concerned for the imposition of a major penalty and disciplinary authority, having regard to the circumstances of the case, is of the view that the imposition of the penalty of removal or dismissal from service would be warranted in the case: or (b) in which prosecution is contemplated or may have been launched in a court of law against the employee concerned. If it is

proposed to accept the notice of voluntary retirement even in such cases, approval of the Syndicate in case of employee up to class B and of Senate in all other cases, shall be obtained. Even where the notice of voluntary retirement given by an employee requires acceptance by the appropriate authority, the employee giving notice may presume acceptance and the retirement shall be effective in terms of the notice unless the Vice-Chancellor issues and order to the contrary before the expiry of the period of notice.

17.8. While granting gratuity to an employee retiring voluntarily weightage of up to five years would be given as an addition to the qualifying service actually rendered by him. The grant of weightage of up to five years will, however, be subject to the condition that the total qualifying service after allowing the weightage should not in any event exceed 33 years of service in the case of Class A and B employees and 35 years in the case of Class C employees.

17.9. An employee who retires voluntarily shall be entitled to gratuity, furlough and benefit of encashment of earned leave, as in the case of employees who retire on superannuation, as may be admissible under the rules and regulations."

2. Mr. Surinder Kumar Puri has 26 years qualifying services in his credit.

Shri Ashok Goyal said that no background had been given, e.g. how many years of service had been rendered by Mr. Surinder Kumar Puri, whether he fulfilled the condition of (i) minimum of 20 years of service; (ii) minimum three months' notice period; and what was the reason for seeking voluntary retirement.

The Vice-Chancellor said that the office would be asked to provide the requisite information and the item would be placed before the Syndicate in its next meeting.

This was agreed to.

Issue regarding payment of Conveyance Allowance to 'A' Class Officers of P.U. along with salary **<u>16.</u>** Considered if the Conveyance Allowance to 'A' class officers of P.U. be paid along with Salary and condition of filling in the prescribed certificate each month for claiming the said Allowance be waived off.

NOTE: 1. Presently, conveyance allowance is being allowed only to all 'A' Class Officers of Panjab University vide Punjab Government circular No. 10/16/2001-Estt./(5)/4110 dated 27.4.2005 by way of submission of a Certificate containing claim of benefit excluding all kinds of leaves except casual leave.

> Now, as per the Punjab Government Notification No. 3/09/2011/5FPII/212 dated 19.5.2011 adopted by the Board of Finance dated 27.2.2011, approved in anticipation of approval of Syndicate and Senate, certain categories of Panjab University employees, including Clerks and Assistants, have been granted Conveyance Allowance which has been made a part of the salary and the employees need not to submit any Certificate for claiming Conveyance allowance.

2. The opinion of R.A.O. enclosed (Appendix-IX).

Shri Ashok Goyal stated that there was difference between conveyance allowance as part of the salary and conveyance allowance paid as reimbursement. In the case of Class 'A' officers, the conveyance allowance is being reimbursed on the submission of a Certificate containing claim of benefit excluding all kinds of leaves, except casual leave. That was why, in their case it is perhaps not taxable? Wherever it is being paid as part of the salary, it is taxable. He, however, suggested that since they were following the Punjab Government in the matter of pay-scales and allowances, a clarification should be sought from the Punjab Government if the Government had started making the payment of Conveyance Allowance without the prescribed *pro forma* Certificate, then the University should adopt the same.

On a query made by Shri Ashok Goyal about the basic purpose for bringing this item before the Syndicate, it was clarified that the step would reduce the paper work, but it was not found justifiable.

RESOLVED: That the consideration of the item be deferred. In the meanwhile, clarification be sought from the Punjab Government whether they have made the payment of Conveyance Allowance as part of the salary to the 'A' class officers without the prescribed *pro forma* Certificate for claiming the Conveyance Allowance.

<u>17.</u> Considered minutes dated 25.6.2012 (**Appendix-X**) of the Committee constituted by the Syndicate to look into the issue pertaining to Election for the Senate from the Registered Graduates Constituency and recommendations of the Committee constituted by the Vice-Chancellor under the Chairmanship of Shri V.K. Sibal to review the process to be followed in smooth and transparent conduct of Senate Election.

Principal R.S. Jhanji, referring to setting up Polling Booths in Himachal Pradesh, Delhi, Dehradun, Sri Ganganagar and Jammu and

Recommendations of the Committee dated 25.06.2012 pertaining to election for the Senate Kashmir, enquired as to why the system which was functioning smoothly is being discontinued.

Shri Gopal Krishan Chatrath stated that, in fact, their proposal was that they wanted to eliminate the menace of bogus voting. The Committee considered the issue and made recommendation 3, but when he and Shri Ashok Goyal examined the issue they found that as per Regulation 12, a person who is in the possession of such and such documents should be allowed to cast his/her vote. He would like to add only one thing that the identity card with photograph issued by the employer to its own employees should be accepted.

Shri Jarnail Singh stated that perhaps the Polling Booths had already been created and the voters had also been informed where they were supposed to cast their votes. Therefore, if any change is to be made, it should be given effect from the next Senate election. Referring to recommendation 3 of the Present Committee that 'Any Identity proof with photograph may be accepted', he said that it would encourage bogus voting. He, therefore, pleaded that Presiding Officers should be directed to allow only those voters to cast their votes, who had genuine Identification proof, e.g. Driving Licence, Voter Card issued by Election Commission of India, PAN Card, Aadhar Card, Identity Card issued by the Employer, etc.

Dr. Mukesh Arora said that he agreed with Shri Jarnail Singh that in case any Identity proof with photograph is accepted, it would definitely encourage bogus voting.

Shri Ashok Goyal stated that, in fact, the Committee was constituted by the Vice-Chancellor to look into the issues pertaining to election of the Senate, i.e. from all the constituencies and not for the purpose of election from the 'Registered Graduate Constituency' only. The Syndicate constituted 2-member Committee comprising Shri Gopal Krishan Chatrath and him (Ashok Goyal). They would agree with him that no Committee had any authority to go beyond what is provided in the Regulations. When the Regulations say that in places other than Punjab, Haryana, Himachal Pradesh, Delhi and Chandigarh, the polling booths shall be set up where there are at least 500 votes in the Registered Graduates constituency. Still the polling booths were being created where the number of voters is less than 500. Thus, there is violation of regulation. Nowhere, it had been mentioned that these recommendations should be implemented from the ensuing Senate election. As far as verification of identity of voter is concerned, the documents enlisted in the Regulation 17 (xviii) page 67 of P.U. Calendar, Volume I, 2007 should continue to be accepted. Whatever concern Principal R.S. Jhanji and Shri Jarnail Singh had shown, the same had been taken care of by their Committee. Chatrath Committee rejected the recommendations of the Sibal Committee as they were in violation of the regulations. Unfortunately, the office did not point out that the recommendations of Sibal Committee were not in accordance with the regulations. The recommendations should have accompanied with an office note that these are in contravention of the Regulation. When the Syndicate constituted the Committee, a news item appeared in the Press that Shri Chatrath and Goyal were sitting over the file because they did not want to implement the recommendations of the Sibal Committee. There were certain recommendations supposed to be implemented from the Senate Election 2012, but the same could not be implemented unless and until the Regulations are amended. The

issue was unfortunately blown out of proportion by the vested interests.

Principal Janmit Singh said that their focus should be as to how the bogus voting could be curtailed.

Principal Tejinder Kaur endorsed the viewpoint expressed by Principal Janmit Singh.

Dr. Mukesh Arora said that main purpose of constitution of the Committee was as to how the dead voters could be eliminated from the list of voters.

Shri Gopal Krishan Chatrath said that in order to curb bogus voting the process for elimination of dead voters should be started at the earliest. Moreover, sensitive Polling Stations should be identified and Observers should be appointed and deputed for overseeing the polling process of those Polling Stations. Further, the Ballot boxes from the Sensitive Polling Stations should be brought to Chandigarh immediately after the closing of voting and necessary arrangements for the purpose be made.

Shri Jarnail Singh suggested that CCTV cameras should be installed in all the sensitive Polling Booths.

Principal Gurdip Sharma suggested that they should act as per Regulations. But Professors and Associate Professors should be appointed as Observers to oversee the polling at the sensitive Polling Stations.

Professor Naval Kishore said that according to him the deterrent to bogus voting is videography of all the Polling Booths.

Dr. Mukesh Arora said that the suggestion put forth by Professor Naval Kishore might not work because videography could be stopped at the time of bogus voting.

Principal K.N. Kaul said that the criteria for setting up of Polling Booths should not be changed and the existing practice should be continued.

Dr. P.S. Gill stated that bogus voting had taken place in the previous election in his College.

Dr. Dinesh Talwar said that since the University employees are put on duty in all the Polling Booths, how could they favour one candidate or the other as they did not have any interest? Unnecessary casting of aspersions on them is not welcomed.

Principal R.S. Jhanji suggested that the persons, who are put on election duty, should be instructed to conduct the election in a fair manner. If need be, surprise checking should be done by sending Flying Squads as was being done to check copying in the examinations.

Shri Ashok Goyal said that in the previous elections bogus voting had definitely taken place because votes of two Lecturers had been polled even though one was hospitalized and other was out of the country. They should evolve mechanism to plug such loopholes. The Vice-Chancellor said that his Secretary had noted the discussions. He had acted as Election Commissioner in the General Elections and knew the process deeply. He and the Registrar would prepare a detailed note on the issue, which would be placed before the next Syndicate.

RESOLVED: That, in the Senate Election 2012, the provisions of the Regulations for the Senate Election be followed.

RESOLVED FURTHER: That, in order to curb bogus voting, sensitive Polling Stations be identified, Observers be sent there and arrangements for bringing Ballot boxes from such stations immediately after the closing of polling be made.

18. Considered the recommendation of the Faculty of Law dated 29.3.2012 (Item 17) that the same rules which regulated admissions, promotions and migration to B.A. LL.B. (Honours) 5–Year Integrated course be applied to B.Com. LL.B. (Honours) 5-Year Integrated course started from 2011-2012.

Shri Ashok Goyal proposed that since the proceedings of the meeting of the Faculty of Law as also the Regulations and Rules for B.A. LL.B. (Honours) 5-Year Integrated course, which are to be followed in the case of B.Com. LL.B. (Honours) 5-Year Integrated course, are not attached, the consideration of the item should be deferred.

This was agreed to.

<u>19.</u> Considered if the validity date of Advertisement No. 10/2010 & 11/2010, for filling up the various teaching/non-teaching/technical posts, be extended for one more year/six months from the lapse of advertisement date (i.e. 11.8.2012 & 10.8.2012). Information contained in the office note **(Appendix-XI)** was also taken into consideration.

Shri Ashok Goyal stated that the validity of posts which were advertised vide Advertisement No.10/2010 is expiring on 11.08.2012, whereas the validity of posts advertised vide Advertisement No.11/2010 is expiring on 10.08.2012. He suggested that the office should be asked to be careful and shun its casual approach. Moreover, from the papers supplied to the members nothing is clear and looked that the selection process was under way. He, therefore, suggested that instead of revalidating these advertisements, the posts should be re-advertised with the instruction that the candidates, who had already applied in response to Advertisement Nos. 10/2010 & 11/2010, need not apply, but they could update their *curriculum vitae*.

Dr. P.S. Gill and Principal R.S. Jhanji suggested that the applicants should be instructed to attach 9 copies of their application only and not of all the enclosures, which could be made available in the Compact Disk.

Shri Gopal Krishan Chatrath stated that it should be ensured that the members of the Selection Committee get the copies of the applications of the candidates appearing in the interview well before the meeting of the Selection Committee so that they could know the merit of each candidate.

At this stage, Shri Jarnail Singh stated that in the last meeting of the Syndicate (Para 44(i), it had been decided that an honorarium @ Rs.1000/- per lecture be paid to the Guest Faculty for practical classes. He pointed out that the Guest Faculty who delivered lecture in theory classes are paid Rs.1,000/- per lecture/per hour. Since the practical are of 2 to 3 hours, the teachers conducting these practical should also be paid @ Rs.1,000/- per hour. Due to this, the teachers are reluctant to perform practical duties. He, therefore, pleaded that rationalization of honorarium of practical should be done. He also handed over a representation **(Appendix-XII)** to the Vice-Chancellor on the floor of the House. He was supported by Principal R.S. Jhanji.

The Vice-Chancellor stated that for preparing to deliver a lecture of 1 hour duration, one has to often devote at least 10 hours, whereas for conducting a practical, one typically just supervises. Hence, both could not be equated.

RESOLVED: That a Committee comprising 3 Principals of affiliated Colleges, one person each from Science and Arts Faculty, be constituted by the Vice-Chancellor to examine the issue and make recommendations. The Committee can co-opt any person, if it deems necessary.

Shri Gopal Krishan Chatrath stated that on the basis of his experience he could inform the House that even the decisions of the Syndicate and Senate are not implemented by the RAO. Until now they are following the system of pre-audit. Now, the time had come that they should go in for post audit. The internal audit should be got done by a team headed by the Finance & Development Officer. Thereafter, the audit should be done by a C.A. as is being done in Government Departments. Since the RAO is raising several objections, the day is not far away when the persons had to approach the Court to get their amount recovered. In fact, the RAO is eroding

Dr. P.S. Gill stated that letters regarding grant of affiliation/extension of affiliation, in anticipation of the approval of Syndicate, had already gone to the Colleges. Referring to grant of temporary extension of affiliation to S.D.P. College for Women, Daresi Road, Ludhiana, Dr. Mukesh Arora stated that though M.Sc. (Mathematics) course was being offered by the College, no teacher was there to teach the students. Earlier, two teachers were there. Now, one of them had proceeded on leave and resignation from another teacher had been obtained by the College a couple of days before. He pleaded that an enquiry should be got conducted by a Committee as to how the M.Sc. (Mathematics) course is being taught in the College.

Professor Naval Kishore stated that a complaint was received from the faculty of the College. A Committee was appointed to examine the issue. But before the meeting of the Committee was convened, the University received a letter that they had reached at a compromise. Thus, the issue had been resolved and there is no complaint now.

The Vice-Chancellor said that they would write a letter to the College to send a copy of the issue-wise compromise arrived at between the faculty and the management of the College.

Issue regarding grant of grace period to clear NET

36. Considered if Shri Manjit Singh, Assistant Professor, Computer Science, Malwa College Bondli Samrala, District Ludhiana, be given a grace period of two years more for clearing the NET examination as a special case as he has failed to qualify the NET examination within two years from the date of his appointment.

- **NOTE:** 1. A letter No. MC/1777 dated 26.4.2012 of the Principal, Malwa College Bondli Samrala, District Ludhiana, with regard to retain the services of Shri Manjit Singh, Assistant Professor enclosed (**Appendix-XXI**).
 - 2. Recommendation of the Law Officer, dated 19.5.2012 enclosed (**Appendix-XXI**).

Principal Janmit Singh said that why a grace period of two years more for clearing the NET examination was being given to only to Shri Manjit Singh, Assistant Professor, Computer Science, Malwa College Bondli Samrala, District Ludhiana. He pleaded that, if at all, this grace period is to be given, it should be given to all similarly placed candidates.

Principal Gurdip Sharma stated that a Committee had been constituted to explore the possibility of appointment of teachers in the

subject of Computer Science without NET as there was shortage of NET qualified candidates in this subject. He informed that there were only 5-6 NET qualified candidates in the subject of Computer Science in the northern region. He was also a member of the said Committee, but no meeting of the Committee had been convened so far.

Professor Naval Kishore said that the point raised by Principal Gurdip Sharma would be checked.

Continuing, Principal Gurdip Sharma said that there was a proposal to make M.Tech., M.C.A. and M.E. candidates eligible for the post of Assistant Professor in the subject of Engineering because there was no provision for NET.

Principal Tejinder Kaur pleaded that along with the subject of Computer Science, the candidates without NET should also be allowed to be appointed in the subject of Fashion Designing as no NET was being conducted by the U.G.C. in this subject.

The Vice-Chancellor requested the members to give a solution to the problem through the Committee.

Dr. P.S. Gill said that since no NET is being conducted by the U.G.C. in the subject of Fashion Designing and NET qualified candidates are not available in the subject of Computer Science, the candidates without NET should be allowed to be appointed.

Professor Naval Kishore suggested that wherever NET qualified candidates are not available, appointment could be made as contractual faculty for one year.

Shri Gopal Krishan Chatrath said that the appointments in professional subjects could be made in accordance with the qualifications approved by the AICTE.

Shri Ashok Goyal stated that the condition of qualifying the NET within two years was imposed on Shri Manjit Singh, Assistant Professor, Computer Science, Malwa College Bondli Samrala, District Ludhiana, by the Selection Committee. Now, there was no alternative but to advertise the post. If again NET qualified candidate is not found, the Selection Committee might recommend his appointment for one year. He further stated that he had come across such a proposal for the first time, wherein the representation of the College Lecturer had been referred to the Law Officer and the Law Officer had not written a single line, which could be called legal. The Dean, College Development Council, whose area it was, has clearly mentioned that it is not permissible. If NET candidates are not available, he could be appointed for one year based on the decision of the Syndicate taken in its last meeting.

Professor Naval Kishore stated that, of course, there was no fault of the candidate as he was working in the College for the last 2 years. But it is very difficult to understand why the Selection Committee went beyond its jurisdiction by recommending the appointment of an ineligible candidate and imposed the condition that he should qualify the U.G.C. NET within two years. In fact, this condition could be imposed only up to 2009, but not thereafter.
Shri Ashok Goyal said that even if the condition had been imposed by the Selection Committee wrongly, how it is binding on the Syndicate?

Principal Gurdip Sharma said that it was a ground reality that only 5-6 NET qualified candidates are available in the subject of Computer Science in the northern region. He, therefore, pleaded that a grace period of at least one year should be given to Shri Manjit Singh for qualifying the NET.

Shri Jarnail Singh suggested that wherever NET qualified candidates are not available, the appointments on temporary/contract basis should be allowed to be made for one year.

RESOLVED: That -

- (1) Shri Manjit Singh, Assistant Professor, Computer Science, Malwa College Bondli Samrala, District Ludhiana, be given a grace period of one year more for clearing the NET examination as a special case as he has failed to qualify the NET examination within two years from the date of his appointment.
- (2) The decision at (1) above, be also made applicable in the case of all those candidates who are placed in similar position.

RESOLVED FURTHER: That the Committee constituted by the Vice-Chancellor to consider –

- (i) whether the appointment of non-NET candidates should be approved in the subjects in which the NET is not being conducted by the U.G.C.?
- (ii) whether the appointment of non-NET candidates could be allowed in certain subjects (Computer, etc.) in which NET qualified candidates are not available?
- (iii) the subjects which could be covered under the NET in Life Sciences.

be requested to make its recommendations giving a viable solution to the problem of making appointments in the absence of non-availability of NET qualified candidates at the earliest so that proper legitimate appointments could be made before the next academic session.

<u>37.</u> Considered if the template received from the Director Higher Education, Chandigarh Administration as per **(Appendix-XXII) or** the template of the Panjab University for the selection of Assistant Professors in the private Colleges affiliated to P.U., Chandigarh (U.T.) be followed as there are some differences in the two letters.

NOTE: 1. Shri Deepak Sibal, Legal Retainer, has opined that the University should follow the criteria approved by the UGC for the Selection of Lecturers.

Adoption of template

- 2. The Vice-Chancellor D.O. letter No. UT-Govt./733/Vice-Chancellor/DS dated 15.6.2012 on the above subject written to Singh, Shri V.K. IAS, Finance-cum-Secretary, U.T. Chandigarh Education enclosed (Appendix-XXII) and the reply received from Registrar Education (C), Director Higher Education, Chandigarh Administration vide No. 237-DHE-UT-C7-24(52)2010 dated 9.7.2012 also enclosed (Appendix-XXII).
- 3. The template approved by the Vice-Chancellor on behalf of the Senate dated 20.12.2011 for the purpose enclosed (**Appendix-XXII**).

Dr. P.S. Gill stated that this problem is being faced for the last 5-6 months. Despite the start of the new academic session, about 50 appointments were being held up. He pleaded that the template of the University should be adopted and appointments be made accordingly.

Principal Gurdip Sharma suggested that a Committee should be formed to look into the issue.

Shri Gopal Krishan Chatrath stated that it was a serious matter. He added that it was the prerogative of the University to lay down the guidelines instead the Government had laid down the guidelines. If the guidelines laid down by the U.T. Administration was adopted, there would be two sets of guidelines, one for affiliated Colleges of the University situated in Chandigarh and another for affiliated Colleges of Punjab. In view of the above, the Vice-Chancellor should be authorized to take up the matter with the U.T. Administrator or his Advisor. The Director Higher Education, U.T., should also be requested to attend the meeting.

The Vice-Chancellor said that as far as possible confrontation with the U.T. Administration should be avoided, especially keeping in view the interests of the students. For the time being, they could adopt the template given by the U.T. Administration for one year.

Shri Ashok Goyal stated that the message from the chair is well received, but the interim arrangement would sent a wrong signal. They had to solve the problem in the light of the fact that there could not be two sets of norms for the affiliated Colleges of the University. Secondly, as far as internal assessment is concerned, they had already taken a decision that the internal assessment would base on September and December examinations, whereas the U.T. Administration had said that they would not be conducting September Examinations and would chalk out their own criteria for award of internal assessment. If they continued to surrender their academic autonomy like this, they would not be doing justice to the University. Our Vice-Chancellor had written a D.O. letter to the Secretary, Higher Education, but the reply to this D.O. letter was given by the Registrar Education, by saying that he was directed to refer the D.O. letter. This was the attitude present then what would be situation if we surrendered our autonomy. Since the University had developed its own template, the same should be followed.

Professor Naval Kishore said that, of course, the U.T. Administration could not interfere in the academic autonomy of the University. He suggested that if the Registrar Education (C), UT Administration, Chandigarh is invited to the meeting with the Advisor, the position would change.

Shri Gopal Krishan Chatrath stated that they had seen the information given by the Legal Retainer of the University. As per the law, the U.G.C. is the competent authority to frame guidelines and the Government should also follow that. Under Article 254(1) of the Constitution, if there is a law made by the U.G.C. and the State also frames its own law on the issue, the law of the State shall be void to the extent of conflict. As per the proposed template of the U.T. Administration, the nominee of the D.P.I., who is not an academician, is supposed to give assessment out of 20 marks to each candidate appearing in the interview, which was very astonishing.

Dr. P.S. Gill stated that the U.T. Administration is head on collision with the University. The D.P.I. U.T.(Colleges) was not granting benefits to the teachers. There are about thousands cases wherein the Government had not made payment to the teachers.

The Vice-Chancellor said that for the time being the matter should be kept pending. In the meanwhile, he along with Registrar, D.C.D.C., and the Secretary to Vice-Chancellor would be meeting the Advisor to U.T. Administrator and the D.P.I. (Colleges) to discuss the issue.

This was agreed to.

Issues concerning Colleges <u>38.</u> of Education Considered –

- Recommendations of the Committee dated (i) 12.7.2012 (Appendix-XXIII) constituted by the Vice-Chancellor examine mandatory to proformas submitted by the Colleges of Education for admission to B.Ed. Course for the Session 2012-13 before these were verified and Dean, countersigned bv the College Development Council amidst incomplete compliance.
- (ii) Compliance received from the affiliated Colleges of Education (Appendix-XXIII) to the effect of the deficiencies reported by the Inspection Committee after conducting the periodical inspections of B.Ed. Colleges (year 2011-12) and reported to the Colleges for compliance up to 30.6.2012, the date extended by the Syndicate dated 17.5.2012 vide (Para 3) (Appendix-XXIII).

NOTE: A comprehensive self-speaking office note (**Appendix-XXIII**) alongwith its Appendices

elaborating the efforts made by the Office in the direction of getting compliance from the Colleges by the stipulated date and analytical College-wise status of the compliance received, is enclosed for perusal of the members.

Professor Naval Kishore stated that the Committee had been constituted on the basis of periodical inspections of all the Colleges of Education, which was mandatory after every four years. Of course, the members of the Syndicate and Senate had spent a lot of time and submitted an exhaustive report regarding the appointment of teachers, nature of their appointment, pay-scales, etc. Out of 64 Colleges of Education, barring a few others were not following the guidelines of the N.C.T.E., Punjab Government and the Panjab University. As per the guidelines 6 teachers along with a Principal were required to be appointed on regular basis. Earlier, the Colleges were given deadline of 31st May 2012 to comply with the deficiencies pointed out by the Inspection Committees and the same was extended by the Syndicate to 30th June 2012. A letter was written to the Colleges to submit the Compliance Report before the start of the admissions for the session 2012-13. On 1st July 2012, the University received a Notification from the Punjab Government giving the schedule for B.Ed. admission due to which the process for receiving the Compliance Reports was not completed. Thereafter, a High Power Committee was constituted under Ms. Jasvir Kaur Chahal to look into the issue, which recommended that the date for submission of Compliance Report be extended by one month. The Office wrote letters to the Colleges to reply about the number of teachers appointed, nature of their appointment, pay-scale, etc. The response from the Colleges was not encouraging. Of course, some of the Colleges had asked for panels and wanted to hold the interviews, however the previous year also they asked for the panels but interviews were never held. This year the Colleges asked for the panels and interviews were held. The University had also sent a pro forma to the Colleges regarding nature of appointment (whether regular or contract basis), pay-scale, total salary, mode of payment (whether by cheque or cash). The University had received documents from the Colleges and it had come to their notice that the teachers were being paid Rs. 10.000/-, Rs.11,000/-. The number of regular teachers in some of the Colleges ranged between 2 to 3 and in certain Colleges there was no teacher at all. This was the state of affairs going on in the Colleges. After scrutinizing the compliance reports, it had come out that 33 Colleges had not bothered to follow the dictates of the University. To his mind, they should send all the Compliance Report to the Regulatory Bodies, i.e. N.C.T.E. and Punjab Government. If any College did not meet the requirements of N.C.T.E., no admission would be allowed in that College by the University. In the 2nd meeting of the Committee held on 12th July, wherein legal expert Dr. V.K. Bansal was present, the Committee recommended that reasonable time should be given to the Colleges; otherwise, their decision might not stand in the court. Moreover, the University was not in a position to declare this session as 'Zero Session'. As such, the Committee recommended that another period of three months should be given to the Colleges, so that action could be started against the Colleges on sound footing.

Dr. P.S. Gill said that the Colleges of Education were charging a fee of Rs.50,000/- to Rs.1.00 lakh from each student.

Shri Gopal Krishan Chatrath said that some of the new Colleges had crossed their limit and they should be separated from other Colleges. According to him, the Colleges of Education, which had appointed only one teacher instead of 6, should not be allowed to make admissions, whereas those which had appointed 2-3 teachers should be allowed.

Principal R.S. Jhanji suggested that action against the Colleges should be taken in a phased manner because at once the conditions in totality could not be fulfilled at a stretch. According to him, if there are 5 teachers and somebody with Ph.D. is officiating as Principal, such a College could be spared from the action. But the Colleges which had not at all cared for the guidelines of the N.C.T.E., Punjab Government and Panjab University, should be punished.

Dr. Dinesh Talwar stated that the University had done a lot of hard work to present the compliance reports in this form. He, however, enquired do they take pride in increasing the number of affiliated Colleges or wanted to impart quality education to the students. This issue had been discussed in the Syndicate many a times. Now, a comprehensive report had come to them and most of them must have gone through it. Since most of the Colleges, even after a number of reminders, had not paid any heed to the direction of the University, it would be better if the deficiencies pointed out by the Periodical Inspection Committees are sent to the N.C.T.E. and Punjab Government so that none of the Colleges had courage to defy the directions of the University.

Dr. Mukesh Arora stated that for obtaining permanent affiliation, the degree Colleges are required to appoint 2/3 regular teachers. Similarly, if the Colleges of Education had appointed 2/3 teachers on regular basis, no action should be taken against them. At least the Colleges of Education advertised the teaching posts, whereas some of the degree College did not have a single teacher, e.g. S.P.N. College, Mukerian did not have teachers to teach M.A. (Hindi) and M.A. (Punjabi). Similarly, certain Colleges were running M.A. courses with only one teacher, e.g. D.D. Jain Memorial College.

Principal Gurdip Sharma stated that earlier instead of six, the Colleges were allowed to appoint four regular teachers. How that relaxation was given? The University should definitely write to the N.C.T.E. and Punjab Government about the deficiencies of the Colleges of Education. The Punjab Government might cancel the NOC given to the Colleges by them. However, if they did not allow the Colleges to make admissions for the current session, they would not stand anywhere in the Court.

Dr. P.S. Gill said that they could not compare the degree Colleges with the Colleges of Education as the fee charged by the Colleges of Education was between Rs.50,000/- to Rs.1 lac, whereas the fee charged by the degree Colleges was between Rs.12,000/- and Rs.15,000/-.

The Vice-Chancellor said that the Colleges of Education would be asked to comply with the conditions imposed by the Periodical Inspection Committee and concurrently the University would write to the regulatory bodies, i.e. N.C.T.E. and Punjab Government about the deficiencies of these Colleges so that before the next academic session they have concrete plan for action.

Mrs. Junesh Kumari Kackria said that the Dean, College Development Council, had brought a very rationale proposal.

Professor Naval Kishore stated that the University had filed Caveat against all the Educational Colleges. Now, the Court had given judgement in favour of the University. The High Court in the case of one of the Colleges, i.e. Saint Sahara had given stay. In fact, in that case the University had denied admission right to a candidate. He added that the legal system of the University is so that in most of the cases the Advocates of the University did not appear in the Court and the Court gave ruling in favour of the students, of which Colleges took advantage. He enquired whether after giving three months' time to the Colleges for compliance, whether the University could refuse to accept the returns of the students of those Colleges which did not comply with the conditions of the University?

Principal Tejinder Kaur said that one decision they could take was that they should stop giving more unit/s to such Colleges. The Compliance Report under consideration was not just a report, but had brought in many improvements, e.g. making of number of appointments by the Colleges, a number of changes had taken place and 60% of the Colleges had also brought in improvements in their functioning. All these improvements had taken place with the concerted efforts of Professor Naval Kishore, Dean, College Development Council.

RESOLVED: That the Colleges of Education be given a three months' time to meet the deficiencies and submit compliance reports. In the meantime, the deficiencies reported by the Periodical Inspection Committees be sent to the regulatory bodies, i.e. N.C.T.E. and the Punjab Government.

a of <u>39.</u> Considered if, temporary extension of affiliation be granted to G.H.G. College of Education, Gondwal, Raikot District Ludhiana, for B.Ed. NOTE: The Inspection Committee observed that the College has three NET qualified regular approved Assistant Professors and the College authorities were requested to appoint 3 more Assistant Professors on regular basis. The College has informed that they have appointed 4 more Assistant Professors on regular basis in the pay scale of Rs. 15600-39100 + AGP 6000 and mode of payment in cash as per requirement.

RESOLVED: That temporary extension of affiliation be granted to G.H.G. College of Education, Gondwal, Raikot District Ludhiana, for B.Ed. course (100 seats) for the session 2012-13 with the condition that the College will follow the other Instructions/guidelines of the Panjab University/ NCTE/Punjab Government.

Referring to Sub-Item R-(v), Principal R.S. Jhanji pointed out that the condition of P.U. Constituent College at Guru Har Sahai was worse as neither regular Principal had been appointed there nor furniture had been made available.

Shri Ashok Goyal stated that, in fact, earlier the U.G.C. had sanctioned four Constituent Colleges for the Panjab University. Subsequently, it withdrew its approval for P.U. Constituent College at Guru Har Sahai, District Ferozepur. But the Punjab Government had asked the Panjab University to continue with this College. The Dean, College Development Council, might give clarification on the issue. What was required was that they should ensure that the funds which were assured to be provided by the Punjab Government should be got released. He, therefore, pleaded that the matter should be taken up with the Punjab Government.

Shri Gopal Krishan Chatrath stated that when they started P.U. Regional Centre at Muktsar Sahib, the Punjab Government had given a grant of Rs.60 lacs and had promised that they would give the required amount every year, but thereafter no money had been given by them. He suggested that the expenditure to be incurred on the P.U. Regional Centres and P.U. Constituent Colleges should be made a part of the Budget. It being a serious matter, should be taken up with the Secretary, Higher Education (Punjab).

Principal Tejinder Kaur stated that at the time of start of P.U. Regional Centre at Muktsar Sahib, the SGPC had given its building for use by the University. Whatever grant had been promised by the Punjab Government, had not been forthcoming. The position was worse to the extent that not even administrative functions could be smoothly carried out. The faculty appointed left the Regional Centre. It looked that even the Panjab University was not interested to run the Regional Centre at Muktsar Sahib.

The Vice-Chancellor said that he was planning to visit each and every Regional Centre of the University to take stock of the situation prevailing there.

Principal Janmit Singh suggested that the posts of Directors in the Regional Centres should be filled up on regular basis; otherwise, the Regional Centres would not survive for long.

Dr. P.S. Gill said that two years had passed, but even the required appointments had not been made in the Constituent Colleges. He pleaded that the matter should be taken seriously and the appointments should be made immediately.

Professor Naval Kishore stated that at least 56 Assistant Professors had been sanctioned for the Constituent Colleges. Since they had already entered into the second year, 36 more Assistant Professors are required. The item regarding sanction of 36 posts of Assistant Professors was placed before the Board of Finance, but the Board did not approve of the item. Referring to P.U. Constituent College at Guru Har Sahai, he said that the Punjab Government had agreed to give recurring grant, but the U.G.C. had not ratified that they would provide Non-Recurring grant for this College. Could they call it (P.U. Constituent College Guru Har Sahai) a Constitute College? The Constituent College could only be given by the U.G.C., whereas the U.G.C. had withdrawn its approval for this College.

Principal Tejinder Kaur stated that these are academic problems and the academicians should meet and solve these problems keeping in view the interests of the students. Referring to P.U. Rural Centre at Kauni, she said that the appointment of teachers should be made and sufficient funds should be made available to the Centre. She informed that the Regional Centres set up by the Punjabi University and Guru Nanak Dev University were functioning very well, whereas the situation of P.U. Regional Centres was worse.

Referring to Sub-Item R(xx), Principal Gurdip Sharma said that even though there was shortage of teachers in the P.U. Constituent Colleges, the advertisement for filling up posts of Principal and Assistant Professors had been cancelled.

Professor Naval Kishore said that they were following proper procedure for filling up the posts of Assistant Professors in the Constituent Colleges.

Shri Ashok Goyal stated that the posts of Principal and Assistant Professors at P.U. Constituent Colleges were advertised vide Advertisement No.3/2011 along with the posts of Registrar, Controller of Examinations, Dean, College Development Council, etc. But subsequently, as per Advertisement No.5/12 all the posts were readvertised. For cancelling earlier advertisement, the office had taken orders from the Vice-Chancellor and some portion of the advertisement relating to posts of Constituent Colleges was cancelled. Since these posts had already been advertised vide Advertisement No.5/12, the posts advertised earlier need not to be processed.

Principal Gurdip Sharma said that this fact should have been disclosed to them.

Referring to Sub-Item R-(xxviii), Dr. P.S. Gill said that if an extra chance is to be given to clear the reappear to a MBA (Off Campus) student, it should be given to all the students of course who could not clear their reappears within the permissible chances.

Shri Ashok Goyal said that the extra chance had been allowed by the Vice-Chancellor in anticipation of the approval of the Syndicate. No detail of the case pertaining to the candidate to whom the chance had been allowed, had been provided to them. Under the normal course she should have completed the degree in April 2010. What were the circumstances/compulsions under which she had applied for the extra chance?

Shri Jarnail Singh stated that the University had given special chance up to April 2011 irrespective of the chances availed to those students who could not clear their compartment/reappear. He pleaded that a similar chance should be given now enabling the students to complete their degrees.

Principal Gurdip Sharma said that as a goodwill gesture, the special chance should be given on joining by the new Vice-Chancellor.

It was clarified that every such chance, if granted, put a lot of burden on the examination branches, which are already confronting with the shortage of staff and over burdened.

Referring to Sub-Items R-(xxx) and (xxxi), Shri Ashok Goyal stated that the Regulation 18 under which these appointments had been made, did not seem appropriate. According to him, appointments under Regulation 18(b) could be made by the Syndicate as in last paragraph of the Regulation it had been mentioned that The appointment and conditions of service including leave rules in the case of such persons shall be determined by the Syndicate'. Hence, only the Syndicate was competent to make appointment under this regulation. He, therefore, pleaded that the items should be reframed.

The Vice-Chancellor said that these items would be correctly worded while preparing the minutes.

Referring to sub-Item R-(xxxii), Dr. Mukesh Arora welcomed the provision made for the students who were to join this University after doing M.A. Part I (Annual System) to M.A. Part II (Semester System). He proposed that similar provision should be made applicable for the students of degree classes wherever they had shifted to Semester System from Annual System.

Principal Gurdip Sharma said that the proposal made by Dr. Mukesh Arora should be accepted because the wards of Government Employees had to face difficulties owing to the transfer of the parents. It was clarified that the office proposal was on the similar lines, but the Committee did not approve of it.

Shri Jarnail Singh said that it appeared that this facility is being extended to those students who are seeking admission either in the teaching departments of the University or in its affiliated Colleges. But nothing has been mentioned about those students who had done M.A. Part I and wanted to do M.A. Part II (Semester 3rd and 4th) under the Semester System as private candidates.

Dr. Mukesh Arora stated that the improvement of performance was permissible within five years. Whether the students who had done their postgraduation under Annual System would be required to take examination under the annual system or the semester system?

The Vice-Chancellor said that Dr. Mukesh Arora should give his view point in a detailed note, so that the same could be examined.

Referring to sub-Item R-(xxxiii), on a point made by Dr. Mukesh Arora, it was clarified that in the courses where practical are involved the unit consists of 40 students and where these are without practicals the Unit is of 60 students. In M.Sc. (IT), the unit contains 40 students.

Shri Ashok Goyal, referring to grant of extension of affiliation to MCM DAV College, Chandigarh, said that number of seats had not been mentioned for M.Com.I and M.A.I Economics.

It was clarified that wherever neither the number of seats nor unit had been mentioned, one unit be treated.

After decisions on the agenda items were taken, the members started general discussion.

(1) Dr. P.S. Gill stated that an item regarding approval of teachers/Principals was discussed in the Senate dated 20.12.2011 and it was decided that the teachers/Principals once approved by the University stood always approved and need not approve on their shifting from one College to another or on promotion, but the decision had been recorded otherwise.

It was agreed that the decision be recorded as per recordings on the DVD.

Dr. Dinesh Talwar stated that one of the local Colleges was charging a fee of Rs.26,000/- from the students of B.Com. course, despite the fee fixed by the University was much on the lower side and this practice was going on in this College for the past three years. He had proof of this overcharging in the form of receipt. The most unfortunate part was that the receipts of the fee were being issued to the students at the time of centralized admission made by the University.

Professor Naval Kishore stated that the University had clarified that there cannot be two types of fee for a single course. Moreover, there was no difference between the fee structure for normal and self-financing courses, but the Colleges were not following the direction of the University.

Dr. Dinesh Talwar said that the University should take action against such Colleges.

Professor Naval Kishore said that the Colleges were taking the plea that no hike in the fees had been allowed by the University for the last four five years. A Committee may be constituted to consider hike in fee.

Principal Gurdip Sharma said that earlier there were different fee structure for normal courses and the courses run under self-financing scheme.

The Vice-Chancellor said that the fee was used by the Colleges for development activities, acquiring infrastructure, etc. Since the fee had not been increased for the last four- five years, a Committee is required to be appointed to examine this issue, so that the decision is taken well before the start of the next academic session.

Shri Ashok Goyal said that the point raised by Dr. Dinesh Talwar should be discussed in the next meeting of the Syndicate.

The Vice-Chancellor said that somebody must write a detailed note on the issue, so that the same could be discussed properly.

Shri Ashok Goyal stated that he was only concerned that some of the decisions taken by the Senate, may be 4-5 years earlier, had not been implemented which are creating frustration amongst the teachers of Dr. Harvansh Singh Judge Institute of Dental Sciences & Hospital. In fact, a promotion policy was framed for the promotion of the teachers of Dental Institute but till date it had to see the light of the day.

(3)

The Vice-Chancellor said that Shri Goyal should submit a detailed note, so that the same could be considered.

(4) Shri Ashok Goyal stated that there was a serious issue relating to payment of pension to the teachers of the University, who were entitled for pension as per regulations. According to him, this issue had been referred to the Pension Committee. But the Pension Committee had not considered it. Secondly, there were some cases where the widows of the deceased, who expired before implementation of the Pension Scheme. A Committee had been constituted to consider their cases, but no decision had yet been taken. He pleaded that instead of compelling them to approach the court, the University should decide their cases itself.

The Vice-Chancellor said that the latest information available on the points raised would be placed in the form of ATR.

- (5) Principal Gurdip Sharma raised the issue of eligibility affecting the admission to Industrial Chemistry course and handed over the representation to this effect to the Vice-Chancellor on the floor of the House.
- (6) Principal Gurdip Sharma stated that the names of those teachers/Principals, whose cases for approval had been received by the University before the last date of preparation of Voter list, should be included in the Voter List.

Shri Gopal Krishan Chatrath stated that the entire record regarding approval of teachers/ Principals of the affiliated Colleges is available with the Colleges Branch. In view of the preparation of Voter List for the Senate Election 2012, the Colleges Branch should send the information to the Election Cell regarding approval of appointment of teachers/ Principals so that their names could be included in the Voter List.

Shri Ashok Goyal said that whatever had been provided in the Regulations, the same should be followed.

The Vice-Chancellor said that the matter would be looked into by the Registrar, he being the Returning Officer.

(7) Dr. Mukesh Arora stated that the Department of Mathematics was not allowing the enrolment of two persons for Ph.D. under Dr. Kirti Vardhan, one of them happened to be a College teacher having teaching experience of 21 years with M.Phil degree.

The Vice-Chancellor said that the Dean, Faculty of Science, would be requested to look into the matter and send a detailed note to him on the issue.

- (8) Principal Janmit Singh said that due to lengthy process of On-line admission to B.Com. course in the affiliated Colleges situated in Chandigarh and Ludhiana, some seats are lying vacant. He urged that these vacant seats should be allowed to be filled in by the Colleges themselves.
- (9) Shri Jarnail Singh stated that the retired employees had to knock the doors of the Accounts Branch for getting Pension, etc. One of them, who is handicapped, had visited the Accounts Branch at least 10 times. He suggested that a time frame should be determined under which payment of pension, arrears, etc. should be released to the employees. When the issue was raised by him last time, the Vice-chancellor had asked the Registrar to expedite such cases, but even after the lapse of two months nothing had been done.

(10) Shri Jarnail Singh suggested that as there was a great demand for B.Com., B.C.A. and B.B.A. courses, a uniform decision regarding sanction of additional seats to the affiliated Colleges should be taken.

> Shri Ashok Goyal said that in case the additional seats are sanctioned to the Colleges like this, rural area Colleges would be at disadvantage as the students who could not get admission in city/urban area Colleges, would not take admission in rural area Colleges.

> Principal Janmit Singh said that still about 2,500 students are waiting for admission to B.Com., B.C.A. and B.B.A. courses.

Shri Ashok Goyal stated that every year 5 to 10 seats are taken by the affiliated Colleges due to which the total number of seats had reached 70-80 seats. Is it practically possible for a teacher to teach a class of 80 students? The additional seats, if sanctioned, might be misused by the Colleges. If the filling up of the vacant seats is left to the Colleges, what was the idea for making centralized admission?

Principal Tejinder Kaur stated that it was not true as was being assumed by Shri Ashok Goyal. With the sanction of additional seats there is no affect on the sanctioned seats (unit strength). Moreover, the courses were changing drastically. She appreciated the concern of the Vice-Chancellor towards the affiliated Colleges. She also appreciated the way the Vice-chancellor conducted the meeting of the Syndicate.

Principal R.S. Jhanji suggested that the unit strength should be increased by 5 seats, i.e. from 60 seats to 65 seats.

Shri Ashok Goyal said that he had no problem if additional seats are sanctioned in the courses other than those courses where the admission is centralized.

Professor Naval Kishore said that he would submit to the Vice-Chancellor a detailed note projecting the demand of the Colleges.

RESOLVED: That the Vice-Chancellor be authorized to take decision regarding sanction of additional seats to the Colleges, on behalf of the Syndicate.

(11) Dr. P.S. Gill pointed out that in certain Colleges the representation of the teachers on their Governing Bodies was not as per provisions of the Regulations. Sometimes, the Principal also did not conduct election according to the prescribed procedure. Moreover, Principal could not select two teachers for representation on the Governing Body. He handed over a representation in this regard to the Vice-Chancellor on the floor of the House.

(12) On the issue raised by Dr. P.S. Gill regarding issuance of orders of Dr. Dazy Zarabi, in anticipation of the approval of Senate, the Vice-Chancellor said that he had taken note of the case and would see what could possibly be done in her case.
