Regulation 12.2 given at page 64 of P.U. Cal. Vol. I, 2000, which reads as under:-

“The Vice-Chancellor may, in case of any emergency and for reasons to be recorded, postpone at any stage the date of election or elections or the dates for transaction of any business connected with the election, and the matter shall be reported to the Syndicate.”

Note: If any of the dates fixed in accordance with the schedule is a University holiday, the event for that date will be postponed to the next working day, but it shall not effect the date fixed for election.
