Vice-Chancellor's Statement

The Vice-Chancellor said, -

- "(1) Dr. Ronki Ram, Department of Political Science, has been invited as Visiting Professor at the Leiden University, The Hague, Netherland, for a period of two years.
- (2) The Syndicate is the second highest decision taking body of the University after Senate, as per Calendar. Detailed deliberations are made on every

item and every member should contribute in the discussions for the growth of this University. At the same time, I appeal that the sanctity of the discussions and decisions taken must be ensured/maintained right in the House. The decision taken democratically must be acceptable to all.

- (3) Dr. K.K. Talwar, former Director, PGIMER and Fellow, Panjab University, has become Chairman of Medical Council of India (MCI). Dr. Talwar should be felicitated.
- (4)The U.G.C. had invited proposals for grant of Centres of potential excellence. The U.G.C. had received 64 proposals from various Universities. Out of 64, the U.G.C. had selected 16 proposals and 2 are from the Panjab University. The proposals of the University are in the areas of Nanotechnology and Women Studies. The Department of Nanotechnology and Centre for Women Studies of Panjab University would be designated as Centres of potential excellence. Under this scheme, both the Departments would receive a sufficient grant from the U.G.C. An additional grant would be given by the U.G.C. as the University had NAAC accreditation. Soon the Vice-Chancellor would visit Delhi to make detailed presentations of the proposals.

Initiating discussion, Professor Naval Kishore said that Colleges of one Management had separate managing Committees, i.e. Local Managing Committees, which actually send their representatives on the Selection Committees.

Shri Gopal Krishan Chatrath clarified that in Chandigarh, the Colleges of SGPC are minority institutions whereas in Punjab the Colleges managed by Hindu and Christian communities are minority institutions. In this matter, they had to go by the judgement of 11 Judges of the Hon'ble Supreme Court in the case of TMA Pai. The Selection Committees for the affiliated Colleges should be formed for the appointment of Principals and Assistant Professors keeping in view the above judgement.

Dr. Rabinder Nath Sharma pointed out that DAV Management also had Local Managing Committees in Punjab.

Professor Naval Kishore said that, in fact, the Selection Committees should be formed on the recommendation of the Statutory Governing Body of the College concerned.

After discussion, it was -

RESOLVED: That the Item be withdrawn.

Recommendation of the Committee dated 16.3.2009 (Appendix-XXIII) constituted by the Vice-Chancellor to look into the issue of pay scale of Dr. D. Dhawan and R.K. Khullar of Bhai Ghanayia Ji Institute of Health Sciences, Panjab University, Chandigarh.

RESOLVED: That the decision of the Syndicate dated 30.10.2010 (Para 15) with regard to fixation of pay of Dr. Rakesh Khullar, Additional Chief Medical Officer at Bhai Ghanayia Ji Institute of Health Sciences, Panjab University, Chandigarh, at par with Dr. B.S. Lal instead of Dr. D. Dhawan w.e.f. 1.1.2006, be rectified.

Policy for use of IT services

- <u>6.</u> Considered following recommendations of the Committee dated 28.4.2011 (**Appendix-XXIV**), constituted by the Vice-Chancellor, for framing the policy of the use of IT services:
 - 1. The Committee framed the Computer and Computer Network usage Policy of the Panjab University. This policy will be applicable to Teaching and Non-teaching staff and students. This policy will act as a guideline for usage of IT service in the P.U. The similar kinds of

- policies are being followed by various institutes and Universities in India and abroad.
- 2. The Committee is of the view that this policy may be got approved from the authorities and may be put in the Website of the Panjab University. It may be circulated to the teaching, non-teaching staff and could also make it a part of the Handbook of Information/Hostel Prospectus.
- 3. Regarding use of internet services from 8.00 a.m. to 6.00 p.m., it is decided that as far possible only academic sites be allowed.
- 4. To provide better facility in the Hostels, the Company be approached to re-access the need of number of access points (wi-fi) as the number of users has increased 2-3 times in last two years. Accordingly, the recommendation by a network company the process of attaining access points will be initiated.
- 5. Due to the increase of number of users, the manpower deployed for the purpose of helping the students in the hostels be doubled. Two more persons be appointed out of the hostel funds to look in to the problems of the students. Dr. Tankeshwar Kumar and Dr. J.K. Goswami should take steps to employ two persons.

Dr. Gurmeet Singh pointed out that though the Committee was constituted to frame policy for the use of IT services, no policy had been framed except certain guidelines. Referring to availability of internet services from 8.00 a.m. to 6.00 p.m., that too, only for academic sites, he emphasized that internet services should be made available to the students round the clock. Secondly, since the students of the University are matured ones, internet services without restriction of academic sites should be made available to them.

After some further discussion, it was -

RESOLVED: That a Committee comprising of following persons be constituted to look into the matter and make specific recommendations, on behalf of the Syndicate:

- 1. Professor Naval Kishore
- 2. Dr. Gurmeet Singh
- 3. Dr. Tankeshwar Kumar.

Proposal of DPI (Colleges), 7.
Punjab, regarding from introduction of Road subject

- **Colleges),** 7. Considered proposal dated 15.4.2011 (**Appendix-XXV**) received from D.P.I. Colleges (Punjab) with regard to introduction of new subject i.e. "Road Safety" at School and College level.
 - **NOTE:** 1. If the University intends to introduce "Road Safety" as one of the subject at College level the decision may be taken whether it is to be introduced as one more compulsory qualifying subject as in the case of Environmental Education **or** the same is to be introduced as one of the Elective subjects.

2. A detailed office note enclosed (Appendix-XXV).

Dr. R.P.S. Josh pleaded that before introducing the new subject, i.e. Road Safety at College level, the Punjab Government should be requested to lift the ban on recruitment of teachers.

Shri Dayal Pratap Singh Randhawa was of the view that the idea of introducing the subject on Road Safety at the School and College level is very good. It would certainly increase the practical knowledge of the students towards road safety.

Dr. Dharinder Tayal was of the view that if the subject of Road Safety could not be introduced as a full-fledged subject, a couple of chapters on road safety should be incorporated in the Environment Education paper or 7 to 10 lectures should be delivered to students on road safety as was done in the case of Environment Education earlier.

Shri Gopal Krishan Chatrath suggested that the expenditure incurred on introduction and teaching of Road Safety subject should be treated as valid expenditure.

RESOLVED: That the introduction of Road Safety subject at the College level, be approved, in principle, and the modalities be worked out later on.

RESOLVED FURTHER: The Vice-Chancellor be authorized to look into all the aspects, including financial implications, on behalf of the Syndicate.

NOTE: The Syndicate meeting dated 29.6.2010 (Para 78 (xviii) has approved that the re-employments are with the condition that they will take classes regularly in other related departments also on need basis. The re-

employment on contract basis would be on fixed emoluments to last pay drawn minus pension to be worked out on the full service of 33 years both in case of teachers opting for pension or CPF. Salary for this purpose means pay plus allowances excluding House Rent allowance. Payment on this account will be made against the posts of Tutor-cum-Curators in the University School of Open Learning vacated by them on their retirement.

Recommendations of <u>9.</u> Board of Studies in Str. Ayurveda dated 20.3.2011

- **<u>9.</u>** Considered the following recommendation of the Board of Studies in Ayurveda dated 10.3.2011 duly approved by the Faculty of Medical Sciences dated 28.3.2011 (Para 3) (**Appendix-XXVI**):
 - (i) addition of one subject namely Panchkarma, in which theory paper is carrying 100 marks and practical is carrying 50 marks be included in the syllabus from the examination of 2011.
 - (ii) the following amendments in Regulation 6 at page 469 P.U. Cal. Vol. II, 2007 effective from 2011 be made:

The Vice-Chancellor said that Dr. K.K. Talwar, former Director, PGIMER, had put in a lot of efforts and got the above-said Regulations framed.

Ms. Jasvir Kaur Chahal said that Government Teaching Ayurvedic Hospital and Government Hospitals should not be excluded from the institutions from where a student could undergo three months Pharmacy training. They might doubt the integrity of private institutions, but could rely on Government Teaching Ayurvedic Hospital and Government Hospitals. She, therefore, pleaded that the Government Teaching Ayurvedic Hospital and Government Hospitals should be included in the institutions from where a student can undergo three months Pharmacy training.

The Vice-Chancellor said that Dr. K.K. Talwar, who had got these Regulations framed might have something in his mind that was why he had excluded the Government Teaching Ayurvedic Hospital and Government Hospitals from where a student can have pharmacy training. The Vice-Chancellor, however, requested Ms. Jasvir Kaur Chahal to give her viewpoints in writing so that the same could be examined.

After some further discussion, it was -

RESOLVED: That the Vice-Chancellor be authorized to take decision in the matter, on behalf of the Syndicate, in consultation with Dr. K.K. Talwar.

At this stage, the Vice-Chancellor informed that the Ministry of Science & Technology had recently taken a decision to clear the proposal of the Panjab University for purchase of "Tandem Accelerator" worth Rs.80 crore. A Committee of international experts had been formulated and the local members would meet the Committee soon.

The Vice-Chancellor further informed that 6 acres land would be reserved for establishment of Science City at the South Campus. Help from Shri Pawan Kumar Bansal and Kumari Shelja, Union Ministers, would be sought for the purpose.

Dr. Rabinder Nath Sharma stated that the University has agreed to give 10 acres of land for the establishment of 'Science City' at the Campus without deliberating upon the implications of establishment of 'Science City'. 10 Acres of land is a big chunk of land and it would lead to exhaustion of land at the Campus. He apprehended that the 'Science City' at the Campus would become a tourists' spot, which might hamper academic/ research activities. Resultantly, it would also be disadvantageous to the University. Before agreeing to the proposal of establishment of 'Science City', the members of the Syndicate and Senate should be made aware of the advantages and disadvantages of the proposal.

The Vice-Chancellor stated that they required minimum of 2 acres of land for "Tandem Accelerator". Secondly, they have so much infrastructure available in the Science Departments, which can be pooled. Their own people as well as the public at large would be benefitted from the proposal in a big way. The Panjab University has to come forward. The Vice-Chancellor further stated that he was taking up the matter with the Chandigarh Administration for allotment/allocation of land in lieu of the land given to Chandigarh Administration during the term of former Vice-Chancellor, Professor M.M. Puri and was hopeful that he would succeed in getting the land for Education City.

Shri Gopal Krishan Chatrath said that land to be taken from Chandigarh Administration should be closest to the Campus.

Recommendation Board of Control Department of Computer Science & Applications

of 10. Considered recommendation of the Board of Control and and Academic Committee of Department of Computer Science & Academic Committee of Applications dated 7.4.2011 (Appendix-XXVII) for incorporating the following clause in MCA Rules and Regulations with regard to Migration in MCA course in Panjab University:

> "Migration in MCA course is not allowed from any other Universities or Panjab University Regional Centres or any other Institutes to the Department of Computer Science & Applications, P.U., Chandigarh".

Dr. Dharinder Tayal said that the above recommendation of the Board of Control and Academic Committee of the Department of Computer Science & Applications is not appropriate.

The Vice-Chancellor said that the matter would be got examined.

This was agreed to.

Considered Regulations and Rules (Appendix-XXVIII) for M.E. (Manufacturing Technology) Regular & Modular Programmes w.e.f. academic session 2011-2012 as approved by the Dean, Faculty of Engineering & Technology in anticipation of approval of Faculty of Engineering & Technology.

RESOLVED: That Regulations and Rules for ME(Manufacturing Technology) Regular & Modular Programmes w.e.f. academic session 2011-2012, as per Appendix-XXVIII, be approved.

Recommendation of the 12. Committee dated 4.4.2011 regarding grant of Ph.D. increments to the employees

Considered minutes dated 4.4.2011 (Appendix-XXIX) of the Committee constituted by the Vice-Chancellor to frame policy/norms to extend the benefit of Ph.D. increments to the employees appointed in plan/projects/schemes provided the funding agencies agrees for giving benefits to the employees.

Ms. Jasvir Kaur Chahal said that the Committee was constituted to frame policy/norms to extend the benefit of Ph.D. increments, but she did not find any policy in the item under consideration.

The Vice-Chancellor clarified that, in fact, the Committee had recommended that the persons appointed in plan/projects/schemes, provided the funding agencies agree, should be given the benefit of Ph.D. increments.

Dr. R.P.S. Josh pleaded that the persons, who had done Ph.D. under Regulations, should be exempted from U.G.C. NET as recommended by a U.G.C. Committee as he apprehended that such persons, who are working as teachers in certain affiliated Colleges, would be relieved by the Colleges at the end of the session.

Shri Gopal Krishan Chatrath suggested that the candidates, who had done Ph.D. from Panjab University under old Regulations, should be exempted from NET as they fulfilled 7 conditions out of 11 laid down by a Committee of the U.G.C.

The Vice-Chancellor said that the matter would be examined on priority basis.

Dr. Gurmeet Singh said that the teachers, who had done Ph.D., had been granted five increments as provided under the revised pay-scales. He said that certain persons who had done Ph.D. and joined as Assistant professor after 1.1.2006 but prior to the date of notification of revised UGC pay-scales were being denied the benefit of five increments. He pleaded that since the new pay-scale have been implemented w.e.f. 1.1.2006, all such persons should be given benefit of five increments instead of four. It would be a gift to the young faculty members.

Dr. Rabinder Nath Sharma said that in the meeting of the Syndicate held in the month of January 2011 he had demanded that the teachers, who were eligible for lectureship according to the U.G.C. circular of 1995 and whose appointment had been approved by the University, should be made eligible for appointment under new Regulations of the U.G.C. as well. To this, the Vice-Chancellor had assured that he would get the matter legally examined, but till date nothing had been heard on the issue.

The Vice-Chancellor said that due to paucity of time he could not get the matter legally examined. He, however, assured that the matter would be got legally examined at the earliest.

RESOLVED: That the recommendation of the Committee dated 4.4.2011, as per **Appendix**, be approved.

Issue regarding allowing 13. cost estimates

Considered the proposal of the Finance & Development Officer the XEN to approve rough (Appendix-XXX) that the XEN be allowed to approve the rough cost estimates of all works in the Panjab University.

Issue of re-employment of Professor V.K. Jindal, Department of Physics

21. Considered if Professor V.K. Jindal, (Retd.), Department of Physics be re-employed under Rule 8 at page 130 of Panjab University Calendar, Volume III, 2009 on contract basis for a period of one year on fixed emoluments equivalent to last pay drawn minus pension to be worked out on the full service of 33 years both in case of teachers

opting for pension or CPF. Salary for this purpose means pay plus allowances excluding House Rent Allowance.

NOTE: 1. Rule 8 at page 130 of P.U. Calendar, Volume III, 2009 which reads as under:

"A teacher will be re-employed (if he to be) provided he is academically active. His/her academic activity will be assessed on the basis of total information relating to him/her as available in the University Annual Reports. In case any teacher wishes to submit any supplementary data, he may be free to do so. Or, if the Vice-Chancellor needs any additional information before making recommendation, he may invite the teacher concerned for the purpose, or for elaboration/clarification of any points he deems necessary.

If teacher wishes that the extent of academic activity be determined by the Academic Committee of his/her department, he/she may be allowed to do so."

- 2. Professor V.K. Jindal had requested for reemployment after superannuation from the Panjab University service on 31.01.2010 after attaining the age of 60 years. But his request was not considered by the Vice-Chancellor, since he has gone to the Court in CWP No. 1297 of 2010 A.K. Saihjpal and other versus Panjab University and others.
- 3. Professor V.K. Jindal retired on 31.1.2010. He was working as Guest Faculty on an honorarium of ₹250/- per lecture with ceiling of ₹10,000/- p.m. and has vacated the University accommodation on 6.9.2010.
- 4. Now, the Chairperson, Department of Physics has forwarded the application of Professor V.K. Jindal for re-employment after attaining the age of superannuation duly recommended by the Academic and Administrative Committee of the Department dated 28.3.2011.
- 5. His re-employment will be effective from the date of approval of the Syndicate as recommended by the authorities.

Dr. Rabinder Nath Sharma stated that since Professor V.K. Jindal, who is a Professor of international repute, started teaching immediately his retirement with the permission of the Chairman, he

should be given re-employment from the date he started teaching. The payment of an honorarium of Rs.250/- per lecture would be an insult to him as he is a Scientist of international stature. He emphasized that either Professor Jindal should be re-employed from the date he started teaching or should be made a payment of Rs.1,000/- per lecture (as per revised rates).

The Vice-Chancellor clarified that, in fact, Professor V.K. Jindal requested for re-employment after his superannuation from University service on 31.01.2010, but his request was not considered since he has gone to the Court in CWP No. 1297 of 2010 A.K. Saihjpal and other versus Panjab University and others. However, Professor Jindal started teaching the students on his own.

RESOLVED: That Professor V.K. Jindal (Retd.), Department of Physics, be re-employed w.e.f. the date he joins after Syndicate decision, under Rule 8 at page 130 of Panjab University Calendar, Volume III, 2009, on contract basis for a period of one year on fixed emoluments equivalent to last pay drawn minus pension to be worked out on the full service of 33 years both in case of teachers opting for pension or CPF. Salary for this purpose means pay plus allowances excluding House Rent Allowance.

Letters of Officiating Principal, Sant Hari Singh Memorial College for Women, Chella, regarding cancellation of Inspection

22. Considered two letter Nos. SHSMC/206 dated 25.4.2011 & SHSMC/209 dated 26.4.2011 (**Appendix-XXXIII**) sent by the Officiating Principal, Sant Hari Singh Memorial College for Women, Chella-Makhsuspur, District Hoshiarpur, regarding cancellation of Inspection to be conducted by the Inspection Committee constituted by the Vice-Chancellor for the purpose to recommend grant of extension of affiliation for the courses/subjects for the session 2011-12.

- NOTE: 1.(a) Regarding session 2010-11: The affiliation for the courses/subject, B.A.III- English, Hindi, Economics, Political Science, History, Punjabi(C &E), Home Science, Computer Science, Fine Arts, Music (V), Physical Education B.C.A.III and P.G.D.C.A. was granted provisionally to Sant Hari Singh Memorial College for Women, Chella, Makhsuspur Hoshiarpur, subject to fulfilment of certain conditions, compliance of which is still awaited as per the decision of Syndicate vide Para 37(v) meeting dated 6.11.2009 for the session 2009-2010 and the verification of these is pending to date for want of requisite information from the College.
 - (b) Regarding session 2011-12: In the meanwhile, the College has submitted application along with requisite fee for grant of extension of affiliation for the session 2011-2012. The Inspection Committee to inspect the College has been constituted by the Vice-Chancellor and the Inspection was fixed for 28.4.2011 but the

College has sent a letter stating that the Panjab University letter No. Misc./A-4/1-188 dated 4.1.2011 has intimated that extension of affiliation would only be required to be sought by the College for courses if it was not earlier obtained. The College has been informed about the noncompliance of the University conditions, essential for converting the provisional affiliation into permanent affiliation, which have not been reported till date by the College. The College has also been categorically informed that the provisions of letter No. Misc./A-4/1-188 dated 4.1.2011 are not applicable.

The Inspection team for the session 2011-2012 is under an obligation to undertake verification and the compliance of the conditions for the previous years also, but the inspection is deferred, as the College is not prepared to comply with the conditions and submit the report thereof. It is because of this deliberate delay and advertent lapse on the part of the College that the whole process of affiliation remains provisional to date and the mandatory permanent affiliation remains on hold for the non fulfilment of said deficiencies as reported by the Inspection Teams. Further, the refusal of the College in allowing inspection has implications which are being worked out and a final decision to this effect shall be taken at a later date by the Syndicate/Senate. Contrary to the facts on record, the College authorities insist that as the College has already undergone the entire process of affiliation, therefore, letter for cancellation of inspection may be issued and no inspection should be carried out by the Team appointed by the University. As such, the demand of the College is unlawful, unjust and unfair and further processing of the case has been put on hold because of this stubborn attitude of the College.

- 2. The number of permanent, regular and adhoc teachers required to run the College is specified in Rule 9 (v) given at page 189 of P.U. Calendar, Volume III, 2009, teacher required to run college is specified in Rule 9(v) at page 189 of P.U. Calendar, Volume III, 2009, whereupon the required number of teachers is calculated as per the course content detailed in the syllabus.
- 3. It is placed on record that the College has just three regular teachers as per the Annual

Return of the College for 2010-2011 and the College is being run by appointing majority of teachers on ad-hoc basis in contravention of the University rules and regulations.

Regulation 2.1 given at page 171 of P.U. Calendar, Volume I, 2007 states that after an institution has been in existence for three years, not more than 1/5th of the number of teaching staff shall be on temporary basis.

Further, the UGC Regulation 2010 (Para 13.1) also prescribes the appointment of teachers on contract basis normally. It is permissible only when it is necessary and when the student-teacher ratio does not satisfy the laid down norms. In any case, the number of such appointments should not exceed 10% of the total number of faculty positions in a College.

In spite of the repeated violations and the reported deficiencies, the College does not have a regular Principal, it has still sought a panel of experts for the said appointment besides for appointments of teachers in 11 subjects from the University. The University has appointed the required panels.

The Vice-Chancellor stated that the University has to take a uniform decision that all the affiliated Colleges have to fulfil the conditions laid down by the Inspection Committee/s and affiliation would be granted after verification of fulfilment of conditions by the same or another Inspection Committee. The University had already issued a circular in this regard. But certain affiliated Colleges are interpreting the rules of the University according to their convenience. He clarified that till compliance report is not given by the College concerned, the University would have to send Inspection Committee.

Shri A.S. Bedi stated that when Professor R.C. Sobti took over the University as Vice-Chancellor, he came to his office and the Vice-Chancellor asked him to tell the management of the College to go ahead with the starting of the College with minimum subjects after following the Panjab University Rules and Regulations. Thereafter, the Vice-Chancellor constituted an Inspection Committee, which visited the College and deleted certain subjects. At that time, Shri Hardyal Singh was the Director of the College. After some time, the Vice-Chancellor ordered that the affiliation could not be granted to the College. When he along with certain other persons approached the Vice-Chancellor, the Vice-Chancellor replaced certain members of the Committee. Thereafter, a Committee comprising Principal A.C. Vaid, Professor R.K. Sharma and Dr. K. Gauba visited the College and on their recommendation the College was granted provisional affiliation. The College did not know whether affiliation fee has to be paid to the University or not, due to this, the College is in the list of defaulter Colleges. In fact, the fault is of the Deputy Registrar (Colleges) as he did not ask the College to apply for extension of provisional affiliation along with requisite fee.

Continuing, Shri A.S. Bedi stated that Guru Gobind Singh College of Education, Beghpur Kamlooh, Mukerian, had appointed only one permanent teacher. Similarly, one of the D.A.V. Colleges is making payment of salary to the teachers between Rs.7000/- and Rs.8000/- p.m.. S.D. College, Hoshiarpur, has not appointed teachers in the subjects of English, Political Science and Physical Education. In the subject of Commerce, the College was required to appoint 11 teachers, whereas it appointed only 5 teachers. He further said that he visited Sri Aurobindo College of Commerce and Management, Jhande (Ludhiana) and found that only 5 permanent teachers are there. He suggested that a judicial enquiry should be conducted by the University.

Professor Naval Kishore stated that to streamline the affiliation process, it had been decided by the University that while considering grant of provisional extension of affiliation for 2nd year, the Inspection Committee is bound to verify the fulfilment of conditions laid down by the Inspection Committee while recommending provisional extension of affiliation for 1st year. Similarly, the Inspection Committee appointed to consider provisional extension of affiliation for 3rd year, shall also see the fulfilment of conditions imposed by the Committees during 1st and 2nd year. This process would continue till the College is granted permanent affiliation. However, periodical inspections shall be undertaken by the University as per rules. As such, the courses are to be allowed in strict compliance of the conditions laid down by the Inspection Committees. This would lead to lesser burden on the Colleges. One of the Committees comprising Shri Ashok Goyal and Dr. Dinesh Talwar had also recommended that the Committees should go to the College/s till it/these is/are granted permanent affiliation. As pointed out by Shri A.S. Bedi, if the follow up Inspection Committees are not sent to the Colleges, the Colleges would never appoint the stipulated regular teachers and also not pay salary to the teachers as per U.G.C. norms. Professor Naval Kishore said that the Principal of Sant Hari Singh Memorial College for Women, Chella-Makhsuspur, had taken an absolutely wrong stand that the College had affiliation from the University, therefore, no inspections could be held. This is contrary to the facts on record. The College was only granted provisional affiliation which was conditional and subject to compliance of the conditions imposed by the Inspection Committee. In the absence of which permanent affiliation cannot be arbitrarily claimed by the College. The University is the appropriate authority in this regard.

The Vice-Chancellor said that this should not be taken against any particular College rather it should be taken in totality.

Shri Gopal Krishan Chatrath stated that there are two types of Colleges, i.e. (i) Colleges which are granted permanent affiliation by the University; and (ii) Colleges which are granted provisional extension of affiliation by the University. The Inspection Committee would continue visiting the College till it is granted permanent affiliation.

The Vice-Chancellor said that unless and until the compliance is verified by the University, the Committee would continue visiting the College concerned.

Dr. Rabinder Nath Sharma stated that though Guru Gobind Singh College, Gidderbaha, selected a person as Principal, neither appointment letter was issued to the selected person nor the selected person joined the College. In fact, when the selected person demanded salary as per U.G.C. scales, his/her name was deleted from the recommendation of the Selection Committee. In this way, the College had committed a fraud. What to talk of appointing a regular Principal, even the teachers had also not been appointed on regular basis by the College.

Principal Hardiljit Singh Gosal stated that he visited the College and found that though there are 8-9 teachers, attendance of only 4 teachers was found to have been marked in the attendance register. Out of four, Mrs. Suman Sharma had been shown as Principal everywhere, but her attendance had not been marked anywhere. In fact, the University had approved the appointment of one teacher in the subject of Punjabi. He had obtained photocopies of all the relevant documents.

The Vice-Chancellor said that Principal Gosal should submit his report, so that appropriate action could be taken.

RESOLVED: That unless and until the College submit the compliance report with authentic proof, the students' return of the all Colleges be **not** accepted.

RESOLVED FURTHER: That Inspection Committees be continue visiting all the Colleges till permanent affiliation is granted.

Admission Guidelines

23. Considered minutes dated 28.4.2011 (**Appendix-XXXIV**) of the Committee constituted by the Vice-Chancellor for reviewing/finalizing the Admission Guidelines for admission to various courses in the Teaching Departments/affiliated Colleges for the session 2011-2012.

Ms. Jasvir Kaur Chahal suggested that, as provided under the Regulations, 5% relaxation in the minimum percentage of marks should be given to the SC/ST students for admission to various courses.

Continuing, Ms. Jasvir Kaur Chahal stated that the students of C.P.Ed. were being supplied question papers in Hindi and Punjabi languages in addition to English, but the students of M.P.Ed. and B.P.Ed. had been denied this facility. She pleaded that the students of B.Ed. Yoga and Post Graduate Diploma in Yoga Therapy should also be provided question papers in Hindi and Punjabi in addition to English.

The Vice-Chancellor said that due to shortage of translators, this facility could not be extended to the students of M.P.Ed. and B.P.Ed. courses.

RESOLVED: That the Vice-Chancellor be authorized to take decision in the matter, on behalf of the Syndicate.

Issue regarding action against the Paper-Setter

24. Considered if any action is to be taken against the paper setter for mistakes in the manuscript of the question paper of Mathematics (paper: III opt: (ii) Probability, Theory and Numerical Analysis) of B.A./B.Sc.(General) 3rd year (**Appendix-XXXV**) resultantly there were mistakes in printing of the questions which caused harassment to the University.

The Vice-Chancellor stated that there is no mistake on the part of Printer, but the mistake is on the part of the Paper-Setter as he is casual in his approach.

Dr. R.P.S. Josh stated that the issue should have been solved at the level of Board of Studies instead of bringing it to the Syndicate. He further said that if any punishment is awarded to the Paper-Setter, none would come forward for the University work and the University would be in trouble.

Continuing, Dr. R.P.S. Josh suggested that the Conveyance Allowance of the evaluators should also be increased as the present one is very meagre.

After some further discussion, it was -

RESOLVED: That the Vice-Chancellor be authorized to decide take appropriate action in the matter, on behalf of the Syndicate.

Issue regarding audio recording of Syndicate proceedings

<u>25.</u> Considered if, in view of the recent developments, audio recording of the proceedings of the meeting of the Syndicate be allowed.

Dr. Rabinder Nath Sharma and Shri A.S. Bedi were of the view that, in future, the proceedings of the Syndicate meetings should be videographed.

Shri Gopal Krishan Chatrath said that since the present system is working satisfactorily, there is no need to videograph the proceedings of the meetings of the Syndicate.

After some further discussion, it was -

RESOLVED: That a Committee be constituted by the Vice-Chancellor to consider whether audio or video recording of the proceedings of the Syndicate is required or not.

26. Item 26 on the agenda was read out, viz. –

- Dean of Student Welfare under Regulation 1 at page 107 of P.U. Calendar, Volume I, 2007.

- (iii) Dean of International Students under Regulation 1 at page 108 of P.U. Calendar, Volume I, 2007.
- (iv) Dean of Alumni Relations under Regulation 1 at page 109 of P.U. Calendar, Volume I, 2007.

- (i) The term of appointment of the present Dean of Student Welfare, Professor Naval Kishore, Department of Geology is with effect from 2.8.2010 till further orders.

"The Senate may, on the recommendations of the Vice-Chancellor and the Syndicate, appoint a Dean of Student Welfare for such a period and on such terms and conditions as may be determined by them".

The Dean of Student Welfare (Women) would also be Chairperson Grievance Committee for the code of conduct and

discipline for avoidance of Sexual harassment.

III. Dean of International Students

- (i) The term of appointment of the present Dean of International Students, charge with D.S.W. (M) w.e.f. 21.3.2011.
- (ii) Regulation 1 at page 108 of P.U. Calendar, Volume 1, 2007:

Syndicate may appoint a Dean of Alumni Relations. Such appointment may be renewed from year to year but the maximum period for which a person may hold this office shall not exceed five (consecutive) years."

RESOLVED: That the Vice-Chancellor be authorized to appoint Dean of Student Welfare, Dean of Student Welfare (Women), Dean of International Students and Dean of Alumni Relations, on behalf of the Syndicate, under Regulations 1 and 2.2 at page 107, Regulation 1 at page 108 and Regulation 1 at page 109 of P.U. Calendar, Volume I, 2007.

The Vice-Chancellor stated that though the Syndicate unanimously decided that a corrigendum be issued tomorrow after incorporating the missing words in the qualifications for the post of Registrar and Controller of Examinations and the eligible candidates be asked to bring the supporting documents at the time of interview, still so many controversies arose, e.g. somebody sought information under RTI Act and alleged that Syndicate is a confused lot. To keep the sanctity of House and prestige of the University intact, he got legal opinion from the Legal Retainer of the University which clearly says that since the Panjab University is funded by the U.G.C. under Centrally Funded Institute, it is mandatory for the University not to have any other option than to accept U.G.C. qualifications and they should not deviate from it. However, the latest circular of U.G.C. is silent about the qualifications for the post of Dean, College Development Council and for that the House has to take a decision. In fact, the University had prescribed qualifications for the post of Dean, College Development Council, in 1988 as the U.G.C. vide its letter dated 1.12.1988 had said that the qualifications for the post of Dean, College Development Council, shall be the same as for the post of Professor in the University.

The Vice-Chancellor informed the House that the following Rule 2 at page 74 of Panjab University Calendar, Volume III, 2009 is crystal clear that the Syndicate is the competent authority to prescribe qualifications for a post:

"2. The age educational and other qualifications for appointment to a post and the methods of recruitment shall be as prescribed by the Syndicate, from time to time, provided that no one shall be appointed to any post unless he attained the age of 18 years."

Dr. Gurmeet Singh stated that as far as the posts of Registrar and Controller of Examinations, there is no ambiguity. The qualifications for the post of Dean, College Development Council, are there since 1988. But no qualifications had been prescribed by the U.G.C. now. To avoid any controversy, they should accept the qualifications for the post of Dean, College Development Council, which were prescribed in 1988. As far as the post of Associate Dean, College Development Council is concerned, there is no need to fill up that post as the post does not exist in the UGC guidelines.

Dr. I.D. Gaur endorsed the view points expressed by Dr. Gurmeet Singh.

Endorsing the viewpoints expressed by Dr. Gurmeet Singh, Shri Dayal Pratap Singh Randhawa pleaded that the posts of Registrar, Controller of Examinations and Dean, College Development Council, should be re-advertised as per the latest qualifications prescribed by the U.G.C.

Shri H.S. Lucky endorsed the viewpoints expressed by Shri Dayal Pratap Singh Randhawa.

Principal Hardiljit Singh Gosal said that when the post of Associate Dean, College Development Council did not exist in the University, why the University had filled it up.

Shri A.S. Bedi stated that he wanted to clarify that he was not against anybody, but wanted to bring 2-3 points in the notice of the House. When the post of Dean, College Development Council was advertised first time vide Advt. No.16/2010, it was not advertised on probation. But when it was advertised vide Advt. No.2/2011, it was advertised on probation. He enquired why the word 'probation' was added in the Advertisement No.2/2011. In the meeting of the Syndicate dated 17.5.2011, he had raised the issue of qualifications for the post of Registrar, Controller of Examinations and Dean, College Development Council, if he was wrong, why the corrigendum was given in the newspapers.

The Vice-Chancellor said that Shri B.D. Budhiraja, former Dean, College Development Council, was confirmed by the Syndicate and Senate and according to that decision, the post of Dean, College Development Council was advertised on probation.

Continuing, Shri A.S. Bedi stated that, in fact, the advertisement is wrongly given as it had been mentioned in it that the Vice-Chancellor can place name/s of the suitable person/s before the Selection Committee for consideration, which is not applicable in case of applications received in respect of non-teaching posts. Secondly, there is a provision of at least 7 days for sending the agenda papers to the members of the Syndicate and that should be adhered to. He also said that proper notice and sufficient time should be given to the candidates for attending the interview. Citing an example, he said that one of the candidates, who was in Mumbai, received the call letter on Monday, how he could attend the interview on Thursday. He pleaded that the affiliated Colleges should be asked to fill up vacant sanctioned posts.

On this, Vice-Chancellor stated that every-time the qualifications were looked by the Committees to avoid controversies

and it is not right to always blame the Vice-Chancellor. Ours is a democratic system. The latest qualifications were approved by the Committee of Dean Research, Deans of Faculties of Arts and Science. They designed the qualifications to avoid any controversy, but here is a trend to always target the Vice-Chancellor. The members of the Syndicate are aware that they are also members of various Committees and how the system works?

Dr. Dharinder Tayal stated that he was in complete agreement with other members that the posts of Registrar, Controller of Examinations and Dean, College Development Council, should be readvertised as per qualifications laid down by the U.G.C. Referring legal opinion given by Shri Anupam Gupta, Legal Retainer, he stated that he had given his opinion only for the posts of Registrar and Controller of Examinations, but is silent about the Dean, College Development Council. He did not know why? They should keep the past behind and think for future. He, therefore, urged that since the Syndicate is competent to take a decision in the matter, they should take the decision now so that no such problem is faced by the University in future.

Endorsing the viewpoints expressed by Dr. Dharinder Tayal, Ms. Jasvir Kaur Chahal said that they had seen the plight of Screening Committee and problems thereof. She, therefore, suggested that they should have confidence in the Selection Committee to be constituted by the Vice-Chancellor and, hence; allow the Vice-Chancellor to go ahead with the selection.

Dr. R.P.S. Josh was of the view that the posts of Registrar, Controller of Examinations and Dean, College Development Council, should be re-advertised as per qualifications laid down by the U.G.C.

Principal S.S. Randhawa said that the posts of Registrar, Controller of Examinations and Dean, College Development Council, should be re-advertised as per qualifications laid down by the U.G.C. and thereafter if any complaint is made, the same should be ignored.

RESOLVED: That the posts of Registrar, Controller of Examinations and Dean, College Development Council be readvertised as per U.G.C. Notification/Guidelines.

After the above decision was over, the members requested the Vice-Chancellor to allow Shri Gopal Krishan Chatrath to join subsequent discussion on the issue of Associate Dean, College Development Council and Director Public Relations.

Thereafter, Shri Gopal Krishan Chatrath joined the members.

Considered the issue of filling up post of Associate Dean, College Development Council (ADCDC) and whether the person holding the post of ADCDC is to continue since no qualifications have been prescribed by the U.G.C. for this post.

Shri Gopal Krishan Chatrath stated that since the post of ADCDC has always been a bone of contention in the smooth working of the University. This was the reason, the post of ADCDC was not filled up for a number of years. Since the post of DCDC was vacant for a couple of years, Professor Keshav Malhotra was given additional charge of ADCDC on temporary basis. Now, since a person is holding

the post of DCDC, there is no need to advertise the post of ADCDC and, hence; the additional charge given to a person be withdrawn.

Dr. Gurmeet Singh said that since the post of ADCDC did not exist in the U.G.C. Guidelines, there is no need to re-advertise this post.

Dr. I.D. Gour, endorsing the viewpoint expressed by Dr. Gurmeet Singh, said that the post of ADCDC should not be advertised and the same should be abolished.

Shri Dayal Partap Singh Randhawa stated that since the post of ADCDC is ineffective and there is no statutory provision in the Calendar as well as UGC Guidelines, there is no need to fill up this post and the post should be abolished.

Shri H.S. Lucky, endorsing the viewpoint expressed by Shri D.P.S. Randhawa, said that the post of ADCDC should be abolished.

Principal Hardiljit Singh Gosal said that as in the presence of D.R. (Secrecy) there is no need to appoint A.R. (Secrecy). Similarly, there is no need to fill up the post of ADCDC when the post of DCDC is filled up.

Shri A.S. Bedi said that the papers relating to the post of ADCDC be studied first. If this post is created by the Senate, it should be abolished and got ratified by the Senate.

Dr. Dharinder Tayal stated that he was in complete agreement with the members that the post of ADCDC should be abolished, but proper procedure for the same should be followed.

Dr. Jasvir Kaur Chahal said that since the post of ADCDC did not exist in the UGC Guidelines, the same should be abolished.

Dr. R.P.S. Josh was also of the view that since the post of ADCDC did not exist in the UGC Guidelines, the same should be abolished.

Principal S.S. Randhawa said that since the post of ADCDC has become superfluous and did not exist in the UGC Guidelines, the same should be abolished and the person holding this post should be removed.

Dr. Rabinder Nath Sharma stated that they should learn a lesson from the history and experience of filling up of this post. Since this post is superfluous and has always been a bone of contention, it is better to abolish it. It would be an economy measure and bring harmony between affiliated Colleges and University Offices.

The Vice-Chancellor said that though he has his own reservations, he is bound to respect the decision of the Syndicate but the decision has to be ratified by the Senate.

RESOLVED: That the post of ADCDC be abolished in anticipation of the approval of the Senate and the person holding the post of ADCDC be relieved immediately.

The members considered the issue of filling up of the post of DPR and were of the unanimous view that the following Committee of the Syndics be constituted to look into the old qualifications as well as new qualifications laid down for the post of DPR and make recommendations:

- 1. Shri Gopal Krishan Chatrath
- 2. Dr. Rabinder Nath Sharma
- 3. Dr. Dharinder Kumar Tayal.

Considered the issue of qualifications for the posts of Deputy Registrar and Assistant Registrar in the University as per the U.G.C. qualifications/guidelines or according to the already prescribed qualifications by the Joint Consultative Machinery (JCM) and duly approved by the Syndicate.

Dr. R.P.S. Josh stated that as Deputy Registrar and Assistant Registrar in the University are drawing the scales of the Punjab Government and not of the U.G.C. He drew the attention of the House towards Rule 2, Page 74 of Panjab University Calendar, Volume III, 2009 which is crystal clear that the Syndicate is the competent authority to prescribe qualifications for a post. He was of the view that their qualifications should be as recommended by the J.C.M. and duly prescribed by the Syndicate.

Shri Gopal Krishan Chatrath said that the qualifications of Deputy Registrar and Assistant Registrar in the University should be as recommended by the J.C.M. and duly prescribed by the Syndicate.

Endorsing the viewpoints expressed by Shri Gopal Krishan Chatrath, Dr. Gurmeet Singh pleaded that the qualifications for the posts of Deputy Registrar and Assistant Registrar, should be as recommended by the J.C.M. and duly prescribed by the Syndicate.

Shri Dayal Pratap Singh Randhawa and Shri H.S. Lucky endorsed the viewpoints expressed by Dr. Gurmeet Singh.

Principal Hardiljit Singh Gosal said that the qualifications for the posts of Deputy Registrar and Assistant Registrar should be as already recommended by the J.C.M. and duly prescribed by the Syndicate.

Shri A.S. Bedi said that as the Deputy Registrars and Assistant Registrars are drawing the pay-scales of the Punjab Government, their qualifications should be the same as recommended by the J.C.M. and duly prescribed by the Syndicate.

Dr. Dharinder Tayal said that the qualifications for the posts of Deputy Registrars and Assistant Registrars should be the same as has already been recommended by the J.C.M. and duly prescribed by the Syndicate.

Ms. Jasvir Kaur Chahal endorsed the viewpoints expressed by Dr. Dharinder Tayal.

Dr. Rabinder Nath Sharma stated that as the Deputy Registrars and Assistant Registrars are drawing the pay-scales of the Punjab Government, their qualifications should be the same as already recommended by the J.C.M. and duly prescribed by the Syndicate.

After discussion, it was unanimously -

RESOLVED: That the qualifications of the Deputy Registrar and Assistant Registrar should be the same as recommended by the J.C.M. and duly prescribed by the Syndicate as they are drawing the pay-scales of the Punjab Government and the selection process of the advertised posts be started as early as possible.

Recommendations of the Committee dated 23.3.2011 regarding imposition of fine on certain Colleges

28. Considered the following recommendations of the Committee dated 23.3.2011 (**Appendix-XXXVII**) constituted by the Vice-Chancellor in pursuance of the Syndicate decision dated 5.3.2011 (Para 37):

- 1. Roll numbers to all the students who are admitted and fulfil the minimum eligibility conditions prescribed for admission to that course, be allowed to be issued for appearing in the examinations at the nearby centres other than their respective colleges.
- 2. The students who are admitted but do not fulfil the prescribed eligibility conditions, be also allowed to appear in the examination as one time exception to the condition that their results be declared only after they acquire/attain the eligibility conditions.
- 3. From the next year, enforce the time as imposed on the number of students to be admitted.
- 4. An affidavit attested by the First Class Magistrate be taken from the Principals of such colleges to the effect that they will not violate the university rules/regulations in future and in case it is repeated, the university will not admit their students to the examinations in future and the responsibility of the same will be that of the Principals concerned.
- 5. Fine on the Colleges violating the rules/regulations of the University be imposed ranging from minimum of Rs.33,000/- to the maximum of Rs.2.50 lac. depending upon the magnitude/quantum of the violation as mentioned against each College as per authorization given by the Syndicate:

- 6. No student be allowed the benefit of internal assessment unless the internal assessment award is signed both by the Principal and the teacher concerned of the College otherwise the marks be scaled out of 100. Dean College Development Council be authorized to process all such cases as per the provisions contained in the University Calendar.
- 7. A policy for streamlining the grant of affiliation/ extension of affiliation be framed to overcome the difficulties/problems as being encountered with at present.

Dr. R.P.S. Josh said that these Colleges had to suffer because of double punishment, i.e. imposition of fine as well as shifting the Examination Centre of their students to another College/s. He pleaded that since the punishment had been awarded to these Colleges by shifting the examination centre of the students to another College, no fine should be imposed on these Colleges.

The Vice-Chancellor said that the matter would be looked into.

Committee Report

29. Considered the report of the Committee constituted by the Syndicate vide Para 13 dated 29.3.2011 comprising of Shri G.K.
